TREASURERS REPORT – June 30, 2018

Treasurer Duquette reported on the June 30, 2018 financial statements. He discussed two income accounts – fuel flowage fees are \$4,000 under budget and State of NH Registration fees are approximately \$21,000 under budget. For the fiscal year our income was about 100% to budget. The major underruns for our expenses include part-time wages by \$27,000, building & grounds by \$11,000, airfield equipment by \$6,000 and marketing by about \$5,000. Overall for the month we are 72% to budget and 88% for the year to year budget.
