- YOU MUST BE PRESENT ALL ASSIGNED DAYS OF CHRISTMAS MARKET. NO REFUNDS WILL BE ISSUED FOR MISSED DAYS. BY SIGNING YOU ARE INDICATING YOU ARE COMMITTING TO ALL FOUR DAYS OF THE 2019 GEORGETOWN CHRISTMAS MARKET
- ONCE ACCEPTED FULL PAYMENT IS DUE BY NOVEMBER 1, OR YOUR SPOT MAY BE FORFEITED. THE VENDOR FEE IS NON-REFUNDABLE
- STROUSE PARK BOOTHS ARE 8'*6' WITH AVAILABLE ELECTRICITY. BOOTHS MUST BE SET UP AND STAFFED BY 9:30 AM EACH MORNING OF THE MARKET
- BOOTHS ARE NOT SECURE OVERNIGHT. IF YOU CHOOSE TO LEAVE EQUIPMENT OR PRODUCTS IN THE BOOTHS UNATTENDED, NEITHER HGI NOR THE TOWN OF GEORGETOWN ARE LIABLE OR RESPONSIBLE FOR LOSS OR DAMAGE. IF YOU NEED EXTRA STORAGE LET HGI KNOW AND WE CAN DISCUSS DIFFERENT OPTIONS.
- VENDORS MAY NOT HAVE A PRESENCE OUTSIDE OF THEIR ASSIGNED BOOTH.
