## PRESCHOOL REGISTRATION IS OPEN FOR CC AMANA COMMUNITY SCHOOL DISTRICT

Clear Creek Amana Community School District preschools will offer morning and afternoon preschool for the 2020-2021 school year at Amana, Clear Creek, Tiffin, and North Bend elementary sites. Both morning and afternoon classes will be in three hours sessions, Monday, Tuesday, Thursday and Friday. There will be no preschool services on Wednesdays. Students who qualify by age (4 years old on or before September 15th, 2020) will be eligible for FREE preschool, through Iowa's Voluntary Preschool Grant. There are no requirements for residency or income. Families wishing to enroll a child who would otherwise be eligible for kindergarten will be asked to contact building principals directly.

### Creamery Mystery Dinner Theatre Opens Friday McCall Leaves Creamery Admin

Just in time for Valentine's Day, the Old Creamery opens it's 2020 season with their annual, and always entertaining, murder mystery dinner theatre. At the Price Creek Event Center in downtown Amana, this close-to-home venue will be a great setting for a Jim Daab comedy about a game show cast run amuck on the eve of a big payout.

We're happy to see Sean McCall listed as starring in this OCTC production set to open this Friday, Feb. 14.

McCall has left his position as acting artistic director at the Creamery. He is joining his wife, Jackie McCall, in the Quad Cities as she has undertaken a new role as outreach coordinator for the Brunner Theatre at Augustana College, a move that was announced last October.

Katie Colleta and Keegan Christopher have been named interim artistic co-directors by the Creamery's board of directors led by board president Peter Teahen.

This weekend marks the opening of the professional company's 2020 season. Here's a quick history of the company based upon the company website and articles that have appeared in Willkommen and the Cedar Rapids Gazette over the years. The acting company was founded in 1971 and the following year opened the "Creamery Theatre" in an old dairy in Garrison, Iowa. With the generous support of Martha Ellen Tye of Marshalltown, the company purchased a bus and began touring Iowa - performances of theatre classics, new drama and comedy built the company as a statewide presence. By 1976 the company was performing in 200 communities in Iowa as well as hosting shows in Garrison. In 1980 the company received the Governor's Distinguished Service Award for helping build arts education and bring the arts to rural Iowa.

In 1985 the company received a National Endowment for the Arts Advancement Grant as a professional theatre based in small town Iowa, offering rural communities and schools in Iowa live theatre.

In 1987 when the opportunity arrived to build a new center in the Amanas that could serve as a theatre, meeting place and visitor center, the Amana Society invited the Old Creamery Theatre to come to Amana.

The Creamery accepted the invitation and the Amana Visitor Center was designed as a multi-use theatre space with a 275-seat auditorium for the Old Creamery with input from Creamery Director Tom Johnson and members of the Creamery who worked with Dennis Schrag of the Amana Society and the Amana Society Builders. The building also was to serve as the Amana Colonies Visitor Center and home of the Amana Colonies Convention and Visitors Bureau so offices were built on both floors and the lobby included space for brochure displays, an "info booth" and public restrooms. The new building would be a much needed addition to the community before it welcomed the World Ag Expo on September 7 - 10, 1988.

The building opened in July 1988 when the Old Creamery moved in, performing its first show there on July 26, "Cotton Patch Gospel," with music and lyrics by Harry Chapin. The first Amana Old Creamery season ran from July 26 through October 16. It continued to produce and stage shows in Garrison.

The combined used and designation of the new Amana building made it possible to apply for and receive state economic development grant funding. Owned by the Amana Society, the corporation underwrote upfront all debt and provided matching

funds for the grants. The Amana Society then gifted the use of the building to the theatre and the ACCVB. Twenty ACCVB merchant members guaranteed the sale of \$71,000 in Creamery tickets and used ACCVB resources to market the theatre to bus groups and groups, as well as contributing toward its printed programs and ticketing services. The Amana Society provided rehearsal and storage space year-round, free of charge.

While the move created new opportunities for year-round production of stage shows, the original intent of the Creamery theatre – to serve a rural audience and to bring live professional theatre to under-served communities across the state was expanded in Amana, director Tom Johnson stated in feature stories. In the 1990's the Old Creamery Theatre hired an education director and youth tour coordinator to bring a live theatre show to over 200 schools in the state of Iowa, a tradition that continues today. It created the first of a long series of student-written productions on building character that were titled, "Character Counts," and awarded dozens of writing prizes to children across the state.

In 2008 the company added Saturday performances of youth theatre classics and in 2010 the company founded the Camp Creamery summer drama camp for youth, both proved extremely popular.

In 2015 rumors began circulating that the Old Creamery Board of Directors was intending to leave the Amana Colonies. These were later confirmed and the Board announced its intention to move the theatre to North Liberty. In April 2018 a Cedar Rapids Gazette article announced that the Creamery was planning a move to the campus of Kirkwood College. On October 11, 2019 the Cedar Rapids Gazette published an article announcing that Kirkwood College was dropping those plans. Peter Teahan has since publicly stated in The Gazette that the company is still looking for a new home.

Since 2015 representatives of the Amana Society, Inc. and the ACCVB along with several colony merchants and members of the Amana community who have served on past Old Creamery Theatre boards have tried to meet informally and/ or formally with the Creamery to discuss their plans, their goals and the future.

Late last summer, as it typically does, the Old Creamery announced its upcoming season, to be held in Amana. So the 2020 Creamery season begins this weekend with the annual murder mystery dinner theatre run.

Our favorite Sean McCall will be joined by always creative and entertaining Marquetta Senters with an all-star cast that includes Robert Kemp, Hannah Spina, Kent Reynolds and Aaron Brewer as the upstart cast members taping a segment of the hit TV game show, Wheel of Money, only to find out that some one on set has a diabolical plan for winning the cash that has nothing to do with good spelling.

Tickets are \$52 per person (includes the show and a complete four course dinner) and the show runs through March 8. Contact the Old Creamery Box office for tickets at 319-622-6262.

Part of the fun of dinner theatre is indeed, dinner, and the Ronneburg and Price Creek staff have created a special menu featuring four courses - appetizer, salad, main course choice of chicken roulade in marinara or roast beef, baked potato and seasoned vegetable medley, cheese cake with fresh fruit topping.
