<u>CALL TO ORDER</u>: The Meeting was called to order by Mayor These at 7:01 p.m.

Infrastructure Concerns – Resident's Complaints and Distress Caused by Notice to Residents regarding Fire Suppression: Several residents attended the meeting to voice their concerns of the Notice put out regarding this issue by Administration. Several scenarios were put to council on how this matter should be addressed. Former Council members where present also to inform council of the direction that Council had taken regarding all the infrastructure matters in the past. Budgeting issues and administrative matters were also raised.

Alex Eelhart; Maureen Eelhart; Faye Leicht; Cathy Marusak; Dawn Pauls; Doug Pauls; Dave Vallee; and Lindsay Wolfe all left the meeting at 8:00 p.m.

<u>Public Works Report</u>: The public works report was circulated and discussed by council. The Reservoir Upgrades/repair Update was presented and a timeline to notify residents of the water service interruption was determined. Council would like the residents to be aware of this water shut down well before the actual date. Administration is to notify the residents through a mail-out. Council will be expecting the residents to draw enough water to supply themselves for an 8-to-10-hour period. A boil water advisory will be in effect immediately after this shut down. Once this phase of the repair is complete the second phase to extract the standby pump and either repair that pump or replacement will be scheduled. This phase will also require a service interruption.

The Lift Station Roof repair was discussed. Public Works was contacted by Command Roofing (completed the Water Station Repair) on Friday, April 22 and told that although they had scheduled us into their work calendar they could no longer complete this repair because they were unable to get insurance for the work. Mayor These discussed having a sloped roof put on the lift station at this point as it is the easiest roof to maintain.

The culvert that crosses from the north corner of Main Street and Railway Ave to the ditch kitty corner to the Tempo needs to be repaired or replaced. The culvert is crushed under the road and is causing drainage issues due to the restricted flow. Council has determined that this repair will need to be put off until next budget year and Mayor These has expressed an interest in getting a quote to use directional drilling to install a new culvert.

It has been determined that Street Sweeping will be scheduled after the May long weekend and be dependent on the contractor's schedule.

Tree Planting: The arborist has met with Public Works and is working on a quote to plant boulevard trees on the west side of  $1^{st}$  Avenue South and on the east side of

2<sup>nd</sup> Avenue North. Public works has also identified some spruce trees that should be taken down this year for safety reasons. Deputy Mayor Heinz discussed the problem of 'black knot' in the Village and we will be getting the Arborist to address this at some point in time.
