## Upper Peninsula Labor- Management Council Scholarship for High School Seniors

Under the program scholarships will be awarded annually to the winner selected from the applicants who meet eligibility requirements. Annually, one \$500 scholarship will be awarded for the fall semester.

Any high school senior who has participated in a high school collective bargaining workshop is eligible to apply for a scholarship. Payment of the award will be made directly to the student upon providing the UPLMC with proof of enrollment.

All matters pertaining to the selection of the scholarship winner will be decided by the UPLMC Board of Directors and their decision will be final. The scholarship committee will review the applications and choose four to be presented to the Board of Directors. The Board of Directors will carefully consider each application on the basis of the selection criteria. Every applicant will be notified in writing of the outcome of the selection process.

### AWARD RULES

#### ELIGIBILITY

1. Upper Peninsula high school senior
2. No restriction is placed on eligibility because of race, creed, color, sex or nationality.

#### CONDITIONS OF THE AWARD

1. Scholarships will be awarded to high school collective bargaining workshop participants.
2. One scholarship awarded annually to an accredited institution of higher learning or accredited apprenticeship program in Michigan and proof of enrollment is required.
3. The awarded scholarship must be used in the calendar year of receipt.

#### SELECTION CRITERIA

1. Scholarship recipients will be selected by reviewing the essay from all applicants meeting the eligibility requirements.
2. The selection will be made by the Board of Directors during the first meeting in May.
3. The Scholarship Committee reserves the right to review and modify selection eligibility and selection criteria.

#### DECISION OF THE COMMITTEE

1. The Scholarship Committee will consist of the Board of Directors of the UPLMC.
2. Every applicant will be notified in writing of the outcome of the selection process.
3. The decision of the Scholarship Committee will be final.
