Equipment Required:

- Single Action Revolver(s)
- Lever Action Rifle in Pistol Caliber
- Side-by-side, Pre-1899 Pump or Lever Action Shotgun

Ammo:

- Lead bullets ONLY
- Pistol 400-1000 fps
- Rifle 400-1400 fps
- Power factor >60
- Shotgun: Lead shot only; #4 or smaller
- No jacketed ammo of any kind allowed.
