Expression of Interest for operationalization of Tasar CFC

Introduction:-

Jharkhand Silk Textile & Handicraft Development Corporation Ltd., also known as JHARCRAFT, is a government of Jharkhand undertaking. Jharcraft was formed to create sustainable livelihood opportunities in the rural areas, based on Sericulture, Handloom, Handicraft and other allied activities.

In the year 2006, Jharcraft was started as an organisation to create new opportunities in rural areas with an objective to change lives throughout the state. In the first year, the organisation was engaged in organising production units of various categories.

Our vision expands towards fulfilling cumulative dreams through creation of sustainable livelihood models based on sericulture, handloom, handicrafts and allied activities.

Operationalization of Tasar CFC:-

To improve the production of Tasar yarn and increase the productivity of artisans, Jharcraft has established 148 tasar yarn reeling common facility centres (CFCs). These CFCs are equipped Samridhi machine and Unnati machine for high twist and low twist yarn production. In addition to this infrastructure, local artisans were trained in reeling of silk yarn. Jharcraft would like operationalization non-functional CFC with the support of private players to improve the production of Tasar yarn and also to restore livelihood opportunities for skilled manpower.

Eligibility of applicant:-

Individuals/NGOs/ organization having minimum two years of experience in Tasar yarn can apply for. Must have the knowledge of silk processing cocoon to yarn.

Terms & condition:-

1. Jharcraft is willing to lease/rent out non-functional CFCs (common facility Centre) on the basis of machinery & equipments on as it is.

2. Jharcraft expresses to lease out the above CFCs for a specific period of 10 (ten) years.
3. The awarded agency has to pay fixed amount of Rs. 3,000/per month as decided by the Committee/Managing Director, Jharcraft towards lease rent. This lease rental shall be revised 5% every year.
4. All the expenses pertaining to CFCs shall have to be borne by the agency.
5. All the taxes & govt. liabilities etc. shall have be borne by the agency.
6. A security deposit of Rs. 50,000 by way of D.D/RTGS/NEFT is to be deposited in favour of Jharcraft.
8. Decision of installation/Commission of new machines etc. shall entirely vest with the agency.
9. The rent as fixed shall be deposited in specified bank on or before 7th of every month failing which a penalty of Rs. 100/ per day shall be imposed on the agency.
10. The decision of Managing Director, Jharcraft shall be final.
11. In the event of non-compliance of any of the clause, Jharcraft reserves the right to cancel/reject the lease /rent at any time without assigning any reason.
12. The agency has to ensure the employment of the maximum local lady workers.
13. The agency cannot sub-let the premise or cannot use for any purpose other than reeling of silk yarn.
14. Preference to Jharcraft shall be given in supply of raw silk yarn.
15. Any discrepancy shall be settled under the jurisdiction of Ranchi.
16. Incase more than one applicant for a concern CFCs, the awardee will be selected through bidding.
