Essen Wagon Serves our Community Volunteer Steps Down

After more than 15 years, Essen Wagon volunteer coordinator Donna Trumpold is retiring and passing her call sheet to Paula Fels Welsh who is taking on the volunteer coordinator role.

The Essen Wagon has been part of our community for over 30 years providing meals, five days a week, year round to those who need support to stay in their homes or those who are recovering from an injury or illness and can't cook for themselves.

The service is sponsored by the Amana Church. The daily noon meals are prepared at Amana's Colonial Manor and delivered by volunteer drivers. Right now there are 8 drivers involved. Volunteers take turns delivering anywhere from 1 to 12 meals. That's where the volunteer coordinator comes in. She arranges the three-month schedule of drivers, enlists more help if the number of deliveries warrants it and makes sure the drivers know where and to whom they are delivering the meals each day. Because diners have the flexibility to call in anytime for a meal or opt out as diners recover, the delivery list changes.

So the volunteer coordinator, makes daily or nearly daily, contact with administrator Tanya Powell at Colonial Manor while the book-keeping is maintained by the Amana Church's administrator, Elly Hoehnle. The cost is \$4 per meal. Each meal has several courses, including a hot main course, vegetable, salad and/or fruit, bread, butter and dessert. Some families arrange payment in advance or pay by the week. Payment plans are flexible. To sign up contact Tonya Powell at Colonial Manor, 319-622-3131.

Donna Trumpold followed Kim Zuber as volunteer coordinator. Zuber followed Dr. Henry Ruff. Three decades ago Ivan Reihmann took the lead in establishing the service working with the Iowa Heritage Agency on Aging and modeling our program after the "Meals on Wheels" service.

At age 84 Trumpold feels now is the time to step down. "I really enjoyed it. But it's time for another generation to take this on and learn, so that we can keep it going."

She recruited a cheerfully eager, Paula Fels Welsh, to fill her job. Sometimes, however, finding more volunteer drivers has been tough, "That's the part that I liked the least finding volunteers – but we always found them and they are wonderful. Other than that, I have really, really enjoyed it – the daily routine, talking with the drivers, and just knowing it was such a help to people."

Now of course with cell phones and text messaging dispatching the volunteers is a little easier. During the past 18 months a few of their meal delivery protocols had to change in order to keep everyone safe during the pandemic, but they continued to deliver hot meals five days a week.

When Trumpold had hip replacement she engaged the meals to be delivered to her home while she was recovering, "I took the meals and it was wonderful. They brought the meals right to my chair. The food is good and there is a lot of it! It's just nice sometimes too to see a friendly face. That's one thing - this isn't about just the meal delivery – it's about making contact with people." She explains that the drivers try to say "Hello, how are you?" and engage. "I think people really enjoy that aspect of it too, both the volunteers and those getting meals. . . Everyone is so appreciative, so you really know you are helping."

Thank you Donna Trumpold for your years of service! And to all the volunteers, past and present, thank you.

VETERANS' ECHE

Wolfe v. Wilkie Ruling, April 2020

This is good news for veterans who previously applied for reimbursement from the VA for **emergency services** and have been denied.

VA has begun implementing the U.S. Court of Appeals for Veterans Claims (Veterans Court) September 19, 2019, decision in the Wolfe v. Wilkie case, a class action lawsuit involving VA's authority under 38 U.S.C. 1725 to reimburse the reasonable costs of unauthorized **non-VA emergency treatment of a non-service-connected condition**.

The decision impacts claims for reimbursement for which payment was made by a Veteran's health insurance (including private insurance and Medicare), resulting in cost share, coinsurance and/or deductible liability for the Veteran. The ruling requires VA to reimburse those costs, which have not previously been covered by VA.

As a result, the Veterans Health Administration (VHA) has begun paying cost shares, coinsurance and/or deductible amounts for which the Veteran is personally liable after their other health insurance (OHI) has paid. VHA is sending notification letters to Veterans affected by the Court's decision, including the Wolfe class members, whose claims for reimbursement of cost share, coinsurance and/or deductible amounts were previously denied and will be readjudicated consistent with the Court's ruling.

What does the Wolfe V. Wilkie ruling mean for Veterans who have previously paid coinsurance and deductibles as the result of non-service connected emergency care received in the community?

VA will readjudicate previously denied claims for reimbursement of cost share, coinsurance and/or deductible amounts owed by members of the Wolfe class as the result of emergency treatment received in the community for a non-service connected condition. VA is working quickly to notify affected Veterans of this action.

Has VA begun to reimburse Veterans for previously paid cost share, coinsurance and deductibles, as part of this case?

VA began making secondary payments to non-VA providers for cost share, coinsurance and/or deductible amounts shortly after the Court's ruling in September 2019. VA is taking steps to start reimbursing members of the Wolfe class beginning in June 2020. This reimbursement is for class Veterans who have cost share, coinsurance and/or deductible amounts that are unpaid.

If a Veteran is eligible for reimbursement, how will they be notified?

On April 13, 2020, VA began mailing letters to Veterans affected by the Court's ruling. The letters explain what actions VA will take on the Veterans' claims, including readjudication of previously denied cost share, coinsurance and/or deductible amounts, consistent with the Court's ruling.

If a Veteran or a caregiver has a question about whether they are entitled to a reimbursement, who can they call?

Will VA be reimbursing copayments?

No. VA is legally prohibited from paying copayments owed under a Veteran's health insurance, including private insurance and Medicare
