This month, we focus on Water Conservation as our major topic of concern. There is no more precious resource than our water supply in this state and within the South Florida region. As we continue to work and support the efforts to restore the Everglades to their natural state, water conservation and the restoration of natural flow ways and storage areas of water from the Kissimmee Valley down through the Everglades are at the heart of the matter. STATE NEWS FROM AUDUBON OF FLORIDA

Every year Audubon of Florida engages decision makers in Tallahassee and throughout Florida's home legislative districts to conserve, restore, and protect Florida's ecosystems for birds, wildlife, and our communities. With your help we are able to stave off misguided proposals that will have negative impacts on our natural areas, and quality of life. Working with concerned citizens, Audubon members, and other allied organizations we can effectively support progressive initiatives that will leave a natural legacy for Florida.

The Florida Legislature convenes on March 8, 2005. Committee meetings are currently taking place leading up to the session. There are 19 new House members and several newly elected Senators (elected from House seats). Audubon staff and volunteers are working now to create new and build on existing relationships with the leadership of most committees with jurisdiction over environmental and growth issues. We are also hoping for a more balanced approach from House Speaker Allan Bense and Senate President Tom Lee.

This year has a number of challenging issues. Audubon is focusing on routine priorities such as the Everglades and Florida Forever, the state's primary public land preservation program, while playing some defense and offense on brewing growth management and water policy issues. We are never able to anticipate every issue, but this is a brief report of our current focus. **Save this article as a reference as Audubon reports on these important issues:**

Northwest Florida Water Environmental Resource Permit Water Quality Water Policy Center for Birds of Prey As BCAS Conservation Chair,

I would like to briefly highlight two of these critical areas:

Water Policy: To keep Florida's fast growing population and associated development from using the water that is vital to our natural systems for landscape irrigation and other wasteful practices, we need new policy and funding. Audubon has recommended to a stakeholders process organized by the Senate Environmental Preservation Committee the removal of the sales tax exemption on metered water-water delivered to utility customers. This would generate \$216 million that could be used for conservation, capture and reuse of storm water, reinforce consumer water conservation measures, and potentially get more reuse of reclaimed wastewater by large users. March 12, 2005—Loxahatchee Nat'l Wildlife Refuge Field Trip By Fred Griffin, Fieldtrip Chair

Bring your own lunch and


drinks. Bug spray is always wise. Please dress accordingly.

We will look for warblers and small birds on the boardwalk as well as woodpeckers, on the impoundment walk, ducks and wading birds are featured. To get to Loxahatchee National Wildlife Refuge, west of Delray Beach, take the Turnpike to Delray Beach Exit SR 806 or Atlantic Avenue, exit and go west to US41. Take a right on US41 and go north about 3 miles, look on the left for a sign indicating the Refuge. There is an entrance fee. Wakodahatchee is north of Atlantic on Jog Road about 2 miles.

The Florida Homebuilders have joined the challenge to Florida's Water Resources Implementation Rule that specifies how water can be "reserved" to preserve natural systems. Audubon, the Everglades Foundation, and the Conservancy of Southwest Florida have intervened in that challenge initiated by the Florida Association of Community Developers. The developer group says it will drop the challenge if it can secure legislation that gives certainty to water supply for future growth.

Environmental and Everglades Advocacy: Audubon of Florida works very closely with chapters and allies in the environmental community. The main approach is to strive to be collaborative, solution oriented, and to share accurate data.

EXCITING EAGLE STORY!!



When we arrived at West Lake and only saw two or three birds, we waited around for at the same spot, adjusted talons, and a while and were planning to leave, but just as we did, we heard two raptors quarreling, looked up and there, right overhead, 100 feet away was an osprey chasing a bald eagle!!

The eagle flew away, shook off

the osprey and circled back to us, dropped his talons, as a plane does when coming in for a landing, cocked his head around, folded his wings to reduce the lift and dove down on a fish, missed, and powered on to regain height. Sure enough, he looked around down he came, with talons into the water and a hard flap or two, out pops a very nice sunfish, and off he flies.

Everyone cheered; it was a sight none of us had witnessed before!!
