Late entries may be accepted until January 25, 2024 at 12:00pm if the trial has not filled. **NO DAY OF SHOW** entries will be accepted. Judges are limited to 8 hours of judging and a maximum run value, which will require this club to limit entries accordingly

MOVE UPS: Not all level move ups or downs may be possible. You are responsible for notifying the trial secretary in time to process paperwork.

REFUNDS: Entry Fees for withdrawal will not be refunded after the closing date or in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Event Committee. No entry fees will be refunded if the trials cannot open or be completed by reason of riots, civil disturbances, fire, and act of God, public emergency, act of a public enemy, or any other causes beyond the control of the Event Committee.

LOCATION

Trial ring will be in Building "A". This is the first building as you come into our grounds

FLOORING

Flooring is foam matting. The ring area will have a tarp cover over the flooring.

CRATING

Limited crating space will be available in Building A with priority given to committee members and volunteers. All dogs must be on lead or crated at all times unless actively working in the ring. For safety purposes, the use of Flexi leads or retractable type leashes are not allowed inside the building.

FOOD

Lunch will be available for purchase. There are also various fast-food restaurants within 1 mile of the facility, Alum Creek Rd. and 270.

AWARDS

Ribbons or rosettes will be offered for placements, high in class, and new titles. Special awards may be offered.

NOTICE TO EXHIBITORS

Exhibitors are responsible for cleaning up after their dogs. Potty areas designated by the club include the grassy area between the two buildings.

Exhibitors are responsible for being ready to go into the staging area, in the staging area, and waiting for the call to the gate when it is their turn to run. The judge need not wait for any dog holding up a class.

BITCH IN SEASON - Bitches in season (BIS) MAY compete at Barn Hunt trials & fun tests. They will be run at the end of each class. Owners of BIS should crate/confine their dogs away from traffic and other dogs, and potty in the designated BIS potty area. Please notify the trial secretary upon arrival so the running order can be adjusted.
