Julie Bearss - Zoning Inspector

- --She met with Chad Murdock, representative for Crown Enterprises regarding the possibility of First Energy renting property behind the fireworks building to store their equipment during their power line project. She told him since the items would be inside a building it would not be an issue and thanked him for the information
- --She made/received 9 phone calls. --She issued 5 permits.
- --She was informed by Chris Meduri that the fiscal officer can sign a permit when the zoning inspector needs one. Judy Repcik singed a zoning permit for her deck addition.
- --She has confirmed another case of having her voicemail not reach her in a timely manner. So far it has not been critical to anything she's done but she doesn't know what to do about it. Tim will contact Sprint.
