ORDINANCE NO. 18-___

AN ORDINANCE AMENDING SECTION 2-42 OF THE CODE OF ETHICS ORDINANCE FOR THE CITY OF ASHBURN TO PROVIDE RESTRICTIONS ON THE USE OF CITY-OWNED VEHICLES BY MEMBERS OF THE GOVERNING AUTHORITY; REPEALING ALL ORDINANCES IN CONFLICT HEREWITH; AND FOR OTHER PURPOSES.

WHEREAS, the Mayor and City Council have determined that use of city-owned vehicle should be limited to official city business only;

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of Ashburn as follows:

Section 2.42 of the Code of Ordinances of the City of Ashburn shall be amended to include a new paragraph (10). Section 2.42 (10) is adopted as follows:

"Section 2.42 Prohibitions.

No member of the governing authority shall:

(10) Use a city-owned vehicle for a purpose other than official city business. Use of city-owned vehicles shall be limited within the corporate limits between the hours of 8 am and 5 pm unless the city manager provides prior written authorization.
