New Regulation Impacts All CDL Holders

All CDL holders in Maine received a letter from the Bureau of Motor Vehicles around January 1, 2012. The letter has prompted many calls to MMTA asking for clarification of the letter. This article seeks to clarify the purpose of the letter and to inform CDL holders of the history behind the letter and what action is required by them.

The Federal Motor Carrier Safety Administration wants to link the medical card to the CDL license. None of the actual medical requirements have or will be changing, but linking the medical card to the CDL license will eliminate the obligation for drivers who are required to have a medical card, to carry it on their person while driving a commercial motor vehicle.

choices:

INTERSTATE NON-EXCEPTED: You drive outside the borders of Maine or further interstate commerce in Maine and are therefore required to have a medical card. Furthering interstate commerce would be transporting a load that came from outside the borders of Maine, was dropped in Maine and you are transporting the load to its final destination.

INTERSTATE EXCEPTED: You drive outside the borders of Maine or further interstate commerce and are not required to have a medical card because you are exempt per part 390.3(f). These exemptions are not typical of most interstate drivers and this category does not apply to most over the road truck drivers.

INTRASTATE NON-EXCEPTED: You drive only within the borders of Maine but outside 100 air miles. You are therefore required to

have a medical card. This would also apply to transporting hazardous materials that require placards, in Maine.

INTRASTATE EXCEPTED: You drive only within the borders of Maine and within 100 air miles of your normal work reporting location, thus you are not required by regulation to have a medical card.

CDL holders should certify to the most restrictive type of driving that they do and are qualified to perform. For example, if you normally drive within Maine and within 100 air miles, but you have a medical card as you occasionally work for a Hazmat carrier on weekends, you would have to certify as INTRASTATE NON-EXCEPTED because of the requirement to have a medical card when you are transporting the placarded hazmat load.

If you hold a CDL but no longer intend to drive or hold a medical card, you can certify as INTRASTATE-EXCEPTED.

Proposed well to be located no closer than 70 feet from the leach field and 70 feet from septic tank on property. Proposed well to have 6 inch steel casing sealed into bedrock to a depth just above the first fresh water bearing fracture, with a minimum of 20 feet of casing. As an alternative, a minimum of 20 feet of 6 inch steel casing shall be sealed into bedrock with a solid 4 inch liner installed with top and bottom Jaswell type steel core seals with bottom seal just above fresh water fracture and top seal up inside 6 inch steel well casing. Both top and bottom seals shall be water tight. Annual water testing is recommended.

TOPIC: Well Reports:

David Braley reviewed copies of Tom Weddle's Well Reports generated by the Dept. of Agriculture, Conservation and Forestry.



To Summarize:

No action can occur prior to 1/30/12 as BMV is not ready to receive the certifications.

None of the regulations have changed regarding medical cards.



This rule will link the medical card and CDL license and thus eliminate to carry the medical card in the future.

Between 1/30/12 and 1/30/14 all CDL drivers must self-certify to the type of driving they do and provide BMV with a copy of their current

• William S. Mincher, Homeowner – Hansen's Well Drilling Company:

Proposed well to be located outside the Maine Department of Transportation rightof-way for State Route 114, the location of which must be verified at the local D.O.T. field office. The well must also be located as far from the septic system components as practical and completed in the overburden to the depth determined to be most appropriate during installation based on local conditions observed by the driller to avoid salt laden groundwater.

In addition to the above SWAs, there were a total of 8 other SWAs that were reviewed and approved in-house between June and July.
