- WHEREAS, the Summit Lake Paiute Tribe is organized, pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934 (48 Statue 984), as amended, with the Articles of Association, and approved by the Secretary of Interior on January 08, 1965, granting certain powers to the Summit Lake Paiute Tribal Council; and
- **WHEREAS**, the Summit Lake Paiute Tribe is responsible for financial matters and the organization of operating policies to provide accountability of the benefits received by the Tribe on behalf of its members; and
- **WHEREAS,** the 2019 Indian Housing Plan (IHP) states the Summit Lake Tribe will provide a Rehabilitation assistance program to tribal members in the state of Nevada; and
- WHEREAS, Policy Handbooks for the Housing Program were created by the Tribal Council and staff to enable personnel responsible for the Housing Program an outline for program implementation; and
- WHEREAS, The Tribal Council proposes the following Summit Lake Paiute Tribe's Rehabilitation Program Policy, to enable the tribe to meet the Indian Housing Block Grant (IHBG) requirements; and
- WHEREAS, the Summit Lake Paiute Council has deemed it to be in the best interest of the Tribe, to adopt the revisions to Summit Lake Paiute Tribe's Eligibility Admissions and Occupancy Policy and Procedures.
- NOW THEREFORE BE IT RESOLVED, that the Summit Lake Paiute Council, the governing body of the Summit Lake Paiute Tribe of Nevada, hereby approves the adoption of the revised Summit Lake Paiute Tribe's Eligibility Admissions and Occupancy Policy and Procedures.
