

The Court, having read and considered that certain motion ("Motion") filed by Disbursement Services, LLC ("Disbursing Agent"), as the Disbursing Agent appointed pursuant to the *Join Plan of Reorganization Under Chapter 11 of the Bankruptcy Code Proposed by Debtors, As Amended on September 10, 2012* (the "Plan") filed by Western Utah Copper Company ("WUCC") and Copper King Mining Corporation ("Copper King"), for the entry of a final decree closing the Chapter 11 bankruptcy case of Copper King, no opposition to the Motion having been proper, and with good cause appearing, orders as follows:
