

NOMINATION PAPER FOR PARTISAN OFFICE

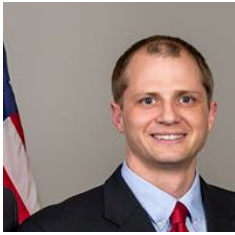
I, the undersigned, request that the name of

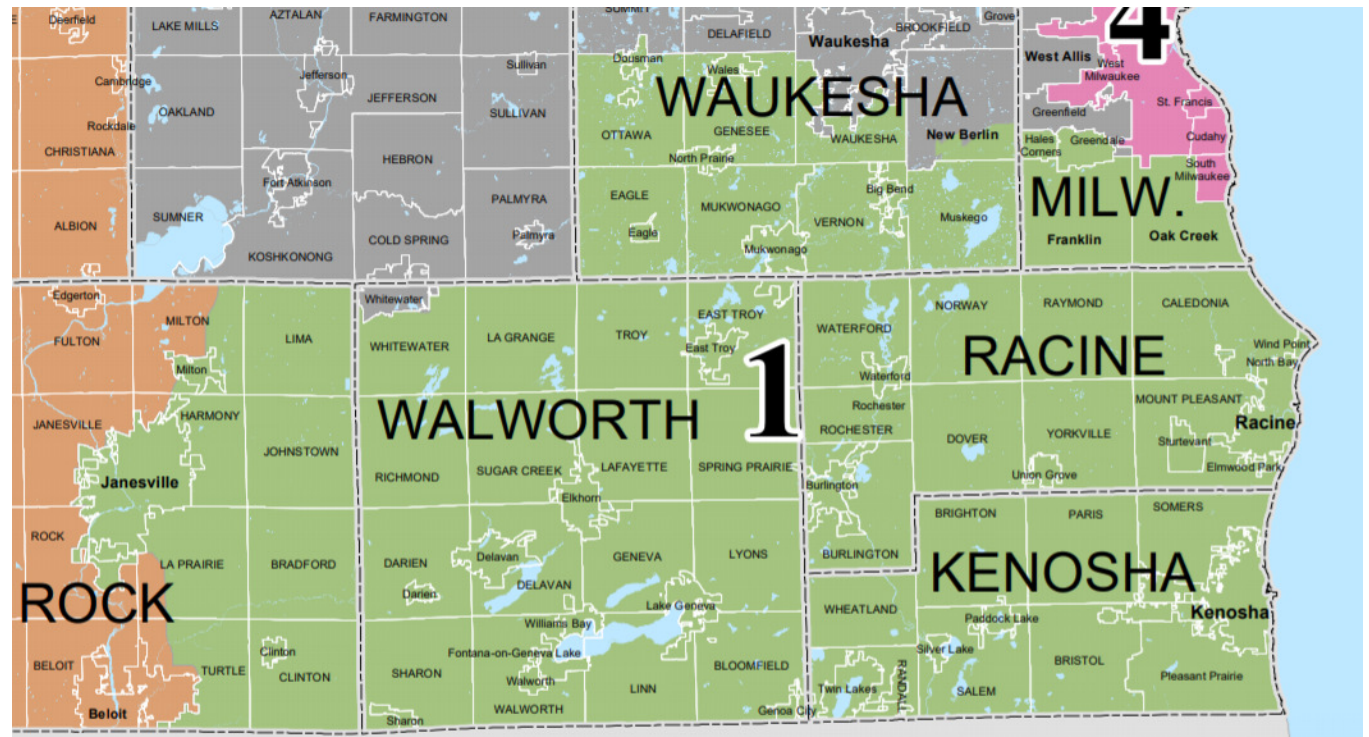
