I, \_\_\_\_\_ the undersigned do hereby agree to provide wine/beer/spirits tasting services at the Cohocton Fall Foliage Festival. The Cohocton Development Corporation agrees to permit such provisions of a wine/beer/spirits tasting service with a Farm Market Permit under the following conditions:

1. The Winery/Brewery/Distillery agrees to participate in the wine/beer/spirits tasting event at The Fall Foliage Festival on Saturday, October 8, 2022 and Sunday, October 9, 2022 between the hours of 10:00 am and 5:00 pm on both days.
2. The Winery/Brewery/Distillery shall set up its tasting area between 8:30 am and 9:45 am on the days of the Event. The Winery/Brewery/Distillery can strike their area after 5:00 pm on the last day of the Event. The area must be totally cleared by 6:00 pm on Sunday, October 9, 2022.
3. The Winery/Brewery/Distillery agrees to file with the Cohocton Development Corporation, no later than September 26, 2022, a Certificate of Insurance with proof at least \$1,000,000 of coverage naming the Cohocton Development Corporation, Town of Cohocton and Village of Cohocton as additional insured.
4. The Winery/Brewery/Distillery will not serve alcoholic beverages to people less than 21 years of age or who appear to be intoxicated. The Winery/Brewery/Distillery shall be responsible for general cleanup in the service area during and after the festival. No products will be left in the tent overnight.
5. The Winery/Brewery/Distillery are responsible to provide their own tasting cups.

Cohocton Development Corporation agrees to provide one 10x10 display space in a tent, one 8-foot table, and ice and water for rinsing your cups.

Please return contracts by September 26, 2022. Space is very limited. Although there are no application fees for your Winery/Brewery/Distillery to participate, it is understood that, by receipt of your application and receipt of your Winery/Brewery/Distillery’s acceptance that you will participate with us and follow all rules and regulations established by Cohocton Development Corporation. If it becomes necessary for you to cancel after acceptance you will contact us as soon as possible so that your place can be filled by another vendor.

The Cohocton Development Corporation, Fall Foliage Festival Committee, Town of Cohocton and Village of Cohocton are not responsible for any theft, loss of property, or personal injury suffered during or as a result of your participation in the Fall Foliage Festival.
