





Course 1: Sustainable Neighborhood Development, Entrepreneurship and Small Business fundamentals, and Understanding the Impact of Business Cycles and Financial Market Condition

Course Description: This session reviews how other neighborhoods, such as Soulsville neighborhood in south Memphis, have successfully been revitalized. This class also gives participants a constructive overview of not only neighborhood revitalization process but also sustainable neighborhood development process.


Running a micro/small business often requires that you become a jack-of-all-trades. 





Contractors' Licenses are required for developers who wish to build their own structures or renovate them. In some cases, they can maximize profits by building the structures themselves. The pros and cons of the two alternatives are highlighted.

A construction license is required for emerging developers who will not only serve as property developers, but would also like to become contractors. A representative from the Louisiana State Licensing and Contractors Board will present information concerning construction licensing.

All design plans and engineering plans must be approved by the local municipality. . In Monroe the Department of Planning and Urban Development – Inspections Division approves all plans and issues permits after a Zoning Compliance Form is approved by Planning and Zoning Division in the same department. Property development aimed at providing residential living spaces to special needs individuals, such as senior citizens, persons with disabilities, and veterans, involves special certifications for their tenants. Information regarding this process will be presented.

Acquiring the proper insurance, such as General Liability, Workers Compensation, Automobile and Professional Services Insurance is s a must when developing properties. The instructor will detail the subject matter.



Mayor James E. "Jamie" Mayo 33rd Mayor of the City of Monroe, Louisiana

James was born in Monroe, LA and he has a B.S. in Business Administration from Northeast Louisiana University (ULM). For the last 20 years, James has worked for companies such as State Farm Insurance, Allstate Insurance, and JP Morgan Chase. He is married to Angela (Washington) Mayo, a retired educator, and they are proud parents of two children (Jared and Ashley) and a grandson (Tyler).

During his political life, he has served a District #5 City Councilman for the city of Monroe between 1995 and 2000. He was appointed Interim-Mayor in June 2001 and elected Mayor in October 2001 – to fill the unexpired term. Later he was re-elected Mayor in 2004, 2008, 2012, and 2016 respectively. As Mayor, he focused on economic development, public safety, partnerships in education, beautification, housing & growth, and marketing Monroe. Under his leadership, Monroe enjoyed a budgetary surplus; the city earned an AA bond rating and continue to build an overall fund balance of more than \$14 million.

These economic development projects highlight some of the achievements of his economic agenda: Monroe is home to the corporate headquarters for the nations' 3rd largest telecommunications company: Centurylink. IBM is constructing an application development and innovation center, which will be the anchor of a new 88-acre lifestyle community development establishment called Century Village. Monroe has built a Fire & Police Public Safety Center and a new Monroe Regional Airport Terminal. A new \$60-million-dollar water system improvement project is now underway. Monroe is currently pursuing a resiliency strategy in collaboration with the Ouachita Parish Police Jury and the City of West Monroe - to secure \$100-million for drainage and flood prevention projects.





Sherman Pittman President, the Gemini Group LLC
