APPROVAL OF APPOINTMENT OF FIRE CHIEF: Mayor Rumpf stated that Jeff Joseph was re-elected as Fire Chief by the current Fire Department members. Jim Nelson moved to approve the appointment of Jeff Joseph as Fire Chief. Harvan Conrad seconded the motion.

JOHN LEE, PRESIDENT OF MAGDALENA CHAMBER OF COMMERCE - REQUEST FOR LODGER'S TAX FUNDING FOR 2023 THE SOURCE VISITOR'S GUIDE ADVERTISING: John Lee, stated that every year the Chamber of Commerce pays for the business cards and the village pays for other information promoting the Village of Magdalena in The Source Visitor's Guide. Donna Dawson moved to approve the request for \$1055.34 from the Lodger's Tax Fund. Harvan Conrad seconded the motion.

DISCUSSION & POSSIBLE DECISION REGARDING QUOTE FROM MOTOROLA FOR MARSHAL'S DEPARTMENT BODY CAMERA, VIDEO TRANSFER STATIONS AND LICENSES: Marshal Michael Zamora has been working with Motorola and Provelocity. He stated that currently the system is easily overloaded and this is a new system that everyone is changing too. Marshal Zamora stated that videos will be stored with Motorola in the Cloud and kept there forever. Provelocity is making sure all software is compatible and working accordingly. Donna Dawson moved to approve the quote from Motorola for the Marshal's Dept., body cameras, video transfer stations and licenses. Clark Brown seconded the motion.

The motion carried unanimously.

PROJECT ROAD FUNDS: Donna Dawson stated that the work needs to begin on 10th Street and there should be no out-of-pocket expenses to the Village. Mayor Rumpf stated that there is erosion near the Magdalena Clinic, the cattleguard needs resizing at State Hwy 107 and Kelly Road needs drainage work. Mayor Rumpf stated that this is new NMDOT Funding, and it is a 100% Grant. Mayor Rumpf stated that he would like to see North Spruce Street extended to Riley Road. Mayor Rumpf stated that there is \$3.5 million in funding. Jim Nelson moved to approve applying for 2023 New Mexico Transportation Project Road Funds. Donna Dawson seconded the motion.

DISCUSSION & POSSIBLE DECISION REGARDING PROFESSIONAL SERVICES AGREEMENT AMONG THE VILLAGE OF MAGDALENA AND THE REGENTS OF THE UNIVERSITY OF NEW MEXICO, AND UNM MEDICAL GROUP, INC.

Jim Nelson stated that the replacement for the current Medical Director is needed because he will be retiring. He stated that they and the Village will be fully covered by our insurance. He stated that it would cost the Village \$3,600.00 per year. He stated that they also carry cyber insurance. Donna Dawson asked if we could go with Presbyterian and Jim Nelson replied that Presbyterian does not offer Medical Directors. Jim Nelson also stated that they offer training opportunities, they're highly professional and will come down and inspect if needed. Donna Dawson moved to approve the Service Agreement between the Village of Magdalena and the Regents of UNM and UNM Medical Group. Harvan Conrad seconded the motion.

DISCUSSION & POSSIBLE DECISION REGARDING APPROVAL TO USE AMERICAN RESCUE PLAN ACT FUNDS (ARPA) FOR THE PURCHASE OF A LOADER FOR UTILITY TRACTOR: Mayor Rumpf stated that we need to work on mowing the streets. The loader should be delivered within the next week. Mayor Rumpf stated that the loader will be a good addition to the Utility tractor. Jim Nelson moved to approve the use the American Rescue Plan Act Funds to purchase the loader for the utility tractor. Clark Brown seconded the motion.
