**County Commissioner** 

County Commissioner Ken Mitchell brought the results from the third-party study of the Prosecutors office which showed recommendations for a salary increase, adding a discovery position, hiring another assistant prosecutor, more thorough training. Prosecutor is confident with the study and would like to move forward.

The county jail implemented tablet use to inmates in which they can use their personal money to text or FaceTime; tablets are returned at the end of the day.

Blue Cross is now providing medical services to inmates; Inmates will use their personal medical insurance and if they do not have any, medical services will be provided for a much lower rate on county insurance.

Library Report

Sara Morrison attended the meeting to give an update for the Briggs District Library. There are plans to give a thorough update to the library, they currently have \$434,000 set aside for renovations. The library has been hosting free to the public programs.

The option was also given to the townships to not join with the county and to hold their own early voting.
