Meeting called to order by Glen Visser, President.

Secretary's Report: Brenda handed out secretary's report from Saturday June 27, 2020 and read off the report. Gordon Sowl made a motion to approve the secretary's report and Paul Orvik seconded. All were in favor. Motion passed.

Pete Woroniecki made a motion to approve treasurer's report and Charles Portz seconded it. All were in favor. Motion passed.

Old Business:

Lights on Bridges: Glen said that he did purchase some solar lights to see how they worked and if they could be used on the bridge but he hasn't had a chance to try them out yet.

New Business:

Youth ATV Safety Training: Glen said that we can hold Youth ATV Training this year but will need to social distance and follow current MN DNR ENF Safety/Education COVID-19 Preparedness Plan. Right now it allows 25 students/instructors outside, 15 inside with 1 instructor. Discussion was had on how many classes should be held since we didn't have one last year. The thought was to hold one at 10am, another one at 1pm and if needed to do another one at 3pm depending on how many registered. Glen thought that it should be held on Saturday May 1st at the Fire Hall with 12 students per class. Everyone was in agreement.

ATV Baja Race: Glen said that he was approached about holding an ATV/UTV Baja Race at Town & Country Days in Twin Valley, MN on a Friday around 6pm in the middle of July of this coming year. It would be a timed race. The Baja Race already has insurance so they would cover the insurance. Glen told him that he would mention it at our meeting but that we did have a lot of other things to take care of this year also. After some discussion it was felt that we had enough on our plate this coming year. Gordon Sowl made a motion to deny doing the ATV/UTV Baja Race and let them know that we are not interested. Paul Orvik seconded. All were in favor. Motion passed.

Noah Insurance: Carolyn printed out the email that Mudslingers received from Noah Insurance letting us know about the renewal of the club insurance. There was no change in premium and will be without the Terrorism coverage \$1,270.48. The Terrorism coverage is \$51.52 a year. Gordon made a motion to pay the premium to Noah Insurance of \$1,270.48 without the terrorism coverage. Pete Woroniecki seconded. All in favor. Motion passed.

Land Lease Renewal: Carolyn said that the campground lease renewal is due April 1st at the cost of \$250.00. It was brought up if it was time for the lease to be redone and Brenda looked at the current lease and said that it was worded: "The term of this lease is three (3) years from and after the 1st day of April, 2018 until March 31, 2021. And thereafter shall be on a year to year basis until terminated by either party as provided herein. The lease payment for any renewals of this Lease Agreement shall continue at \$250 per year unless/until modified by the parties." Carolyn said that she would do a letter with the payment to make sure that they were OK with doing the year to year lease from here on out. Glen said that he will do up a flyer about the ATV Youth Safety Training that will be put with the payment also since Mahnomen Rod & Gun are really supportive of us holding the training. Gordon made a motion to make the payment of \$250.00 to Mahnomen Rod and Gun for the yearly lease of the campground land. Paul Orvik seconded. All were in favor. Motion passed.

Twin Valley Riders Club: Carolyn said that Twin Valley Riders club have had issues with people on ATV's tearing up their grounds. It is private property. They were wondering if we could do a flyer to put up and letting schools know about respecting personal property. They wanted to come to our meeting and discuss this and would still be happy to do that. Glen said that maybe our club could do a little write up in the local papers to let people know what the laws are about operating ATV's. Glen said that even our trail has a lot of vehicle traffic and would like to incorporate that into an ad also. We would need to find out the costs to run in the summer and maybe could split the costs with the Riders Club and the Firefrost ATV Club. We should check with Twin Valley Times, Norman County Index, and Halstad Paper (Valley Journal). It was discussed to maybe get some signs that could be put up stating that no vehicles are allowed on the trail.

Ada-Beltrami Trail: Glen was thinking that the Ada-Beltrami Trail might become official this year. Signs still need to be put up from Lockhart to the County Line so we need to get that in our schedule. Also, some trees just north of Ada need to be trimmed. It was decided to further discuss this issue at the next meeting.
