Westmoreland City Council

February 25, 2022

There being a quorum present, Mayor Jack called the meeting to order at 6:00 PM.

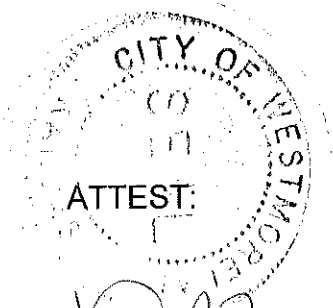
