Pre-entries must be received by **October 2nd, 2021**, at the event secretary's address. Pre-entries are **\$20.00** for the first run and **\$17.00** for each additional run for the **same dog in the same trial**. Discount example. BEGINNING and INTERMEDIATE same dog same trial. If you are entering BEGINNING each trial each day would be \$80.00. If you are entering BEGINNING and INTERMEDIATE each trial, would be \$20 plus \$17 each trial each day. **Following closing date, entries are \$25.00 each class.**

Weekend **GRACH Special: \$50.00-All 3 Levels** for the **same dog/same trial - Pre-Entry Only.**

**Junior Handler entries are \$12.00 Day of Show JR \$15.00**
