Public Forum

Unfinished Business

- 1. Park Board vacancy. Consensus of Board to leave posted.
- 2. Employment requirements. Physical Examinations. Discussed sample provided. Consensus of Board to have committee look at sample and report back at the September 26 meeting.
- 3. Fair Grove Senior Center-sanitary sewer connection issues. (Short): Short stated City Engineer made recommendation which Senior Center agrees with, to cross property of Lions Club (with easement) as is least expensive. Mayor asked if Short would like to table this and move to New Business item #1. Short agreed.

- 1. Charles Huff to discuss sanitary sewer issues for Senior Center: Sewer line for Senior Center discussed. Terry Dean, representor for Huff property spoke for the Huff brothers. Howard Huff present. Dean stated the Huff brothers would like to see the sewer line put in to end at Meadowlark Street (option #2); with the brothers boring some of the cost. Howard Huff saying up to \$20,000. Leon Beaty, Senior Center Board President, stated Senior Center wants to go with easement from Lions Club (option #3). Board has concerns about easement and future development. Terry Smith, Mayor's father, also voiced an opinion. Huff brothers and Senior Center are to work it out and bring decision to Board at next meeting.
- 2. Parking issues on Eagle Ridge Street. (Short): Parking issue, no parking signs and barricades discussed.

Motion by Miller to proceed with amending ordinance Schedule III Parking Restrictions, to a no parking area and have ordinance available for first reading at next meeting. Second Bowman. Discussion. Barricades discussed.

3. Discuss Section 605.190 Prohibiting Soliciting . . . (Short) Short stated he had 2 complaints about traffic being stopped on Highway 125 for annual Fire Fighters Fill the Boot drive for Muscular Dystrophy Association. 7:18 Mayor stepped out. Bowman stated she drove through twice and they do not stop traffic. 7:19 Mayor back. Short proposed changing ordinance wording for this event from Orchard and Hwy 125 to Orchard at Hwy 125. Jerry Bear MDA representative spoke for Fill the Boot drives, stating they are designed not to be a surprise to traffic, are well planned and

- 2. Police accident report: Miller asked if all recovering well. Chief stated yes. Accident discussed. Short asked to see report. Chief Mallory stated he would like to wait till investigation is done first.
- 3. Approve disposal of wrecked police vehicle: Options concerning wrecked vehicle discussed. Lighting and Police equipment can be kept.

Motion by Miller to accept cash value for vehicle because of high mileage of \$8,862 with deductible of \$1,000. Second Counterman. No discussion.
