Results From The Pecan Grove POA Survey Request


At two separate Pecan Grove POA meetings in July 2019, the Grove HOA and other neighborhood boards asked the Commissioner's office to conduct a public survey of Pecan Grove community residents regarding the traffic situation on Plantation Drive. The survey illustrated potentially feasible solutions, and asked the Pecan Grove community to decide if they support or oppose any potential changes.

The results of the survey include 775 responses with 710 **completed** surveys. While there were additional survey responses received from as far away as San Antonio and Missouri, only responses with verified addresses in the Pecan Grove community are included in this data.

Per the results, there was no consensus for action vs. inaction. Out of the 710 completed responses 339 responses did not support any of the options, and 371 responses were in favor of one or more of the potential options. Therefore we found no consensus indicated in the data returned from the survey which means there will be no changes or other solutions made via Fort Bend County and the Precinct 3 Commissioner's office. To address the repeated community concerns about traffic and speed/safety enforcement - Commissioner Meyers has requested specific help via the Fort Bend County Sheriff's Office and Precinct 3 Constable's Office for continued enforcement of traffic laws in and around the Pecan Grove community.

2020 Annual Assessments Due January 1st

The 2020 Grove HOA annual billing invoice will be mailed out in November.

Your assessments are what allow your Board of Directors to maintain your community. The assessments cover the cost of the maintenance of the common areas, as well as other operational costs of the Association (utilities, insurance, management and recreational activities).

The annual assessment for 2020 is \$256.00. A discounted rate of \$225.00 is being offered to all of our homeowners who pay their assessments before January 31, 2020. All past due accounts will be assessed a late fee of \$25.00 along with a monthly collection fee of \$15.00 until paid in full.

Payment plans are available - Three installments may be made: 1) November of 2019, 2) December of 2019 and 3) January of 2020. A total of \$225.00 must be paid in full and received on or before January 31, 2020. If your payment plan runs over the January 31st deadline, you must pay the full <u>\$256.00</u>.

Deed Restriction Top Violations

TOP 5 VIOLATIONS IN OUR NEIGHBORHOOD:

- Exterior Maintenance: Several homes are in need of painting, mildew removal, sagging gutters and rotten wood repair. <u>Remember, ACC approval is required before painting.</u>
- Lawn Maintenance: Lawns need to be mowed, edged and grass needs to be removed from expansion joints.
- Unsightly: Misc. items (coolers, toys, construction material, etc.) need to be stored out of public view. This includes trash cans and debris that need to be stored out of public view until trash day.
- Fencing: Secure leaning fences, missing pickets that need to be repaired, fence replacement. <u>Remember, ACC approval is required before painting.</u>
- Vehicle Parking: Vehicles need to be parked in the driveway or the street. Do not park in the lawn or over the sidewalks.

Our management company, MASC Austin Properties, Inc., sends monthly reminders to all homeowners and residents who are in violation of the community deed restrictions. We are asking everyone to do their part and remedy any existing violations on your property.


Guidelines are put in place to maintain consistency throughout our neighborhood, which enhances the overall appearance and helps retain the market value of our homes. If you are making <u>any</u> type of improvement to the exterior of your home, you <u>must</u> submit an Architectural Improvement request form to MASC Austin Properties, Inc. before starting the work. (This includes painting the exterior and replacement of the roof, driveway and fence.) PCT. 3 VOTER'S GUIDE

NOVEMBER 5 SPECIAL / GENERAL ELECTION



This Nov. 5 voters in Fort Bend County Precinct 3 are being asked to vote on candidates, bond referendums, and constitutional amendments that will have a direct impact on day to day life in our area. What you will find on your ballot will depend on what area you live in & so we've provided a break down on each of the precinct 3 ballot items below.

View the details and the exact ballot wording for all of them or find the ones that apply to you on the following links at <u>https://precinctthree.com/</u> <u>nov2019elections/2019</u>.

All Fort Bend County voters will take to the polls to decide on a Fort Bend County Drainage District Bond Referendum, and 10 proposed amendments to the State's constitution.

- **The majority** of our Precinct 3 residents will be deciding in a special election <u>who of the</u> <u>seven candidates</u> will fill former State Representative Dr. John Zerwas' seat (House D-28).
- Precinct 3 voter's zoned to Grand Lakes MUD No. 4 will be voting on this bond referendum.
- Precinct 3 voters **zoned to Willow Creek Farm's MUD** (along the north-west corner of the county close to Waller County) in <u>will be voting on proposition B.</u>
- City of Weston Lakes residents will be voting on their <u>next mayor</u>.
- City of Sugar Land residents will be voting on the city's G.O. Bond referendum .

• **City of Katy residents** (voters who live in the most northern portion of precinct 3/ along IH10) will be voting on the <u>METRONext Bond Referendum</u>.

Make Sure Your Pet Is On A Leash!



Dogs and cats may not run at large in our neighborhood. **Running at large** means going on public or private property without the owner or another person having direct physical control of the animal. An animal on a leash is considered to be under direct physical

control of a person. When animals are not on a leash they must be otherwise restrained, either behind a fence or in some other enclosure that will prevent their escape. Running at large may result in impoundment of the animal or in the issuance of one or more citations from Fort Bend County.

Scoop The Poop

You can make a difference! Besides being unpleasant to the nose and eyes, pet waste is an environmental pollutant that can seriously harm our waterways. A quick rain shower is all it takes to transfer dog droppings from the ground and into our streams, lakes, rivers and ultimately Galveston Bay. By scooping the poop you are removing harmful nutrients and bacteria from local waterways, keeping our citizens healthy and our yards and shoes clean.


When you take on the role of "pet parent", that comes with the good (puppy and dog snuggles) and the not-so-good (picking up your dog's poop). Invest in some pretty, scented biodegradable poop bags and you can be stylish as well as a responsible and considerate neighbor!

Keep Our Storm Drains Clean!

It is a violation to blow or sweep grass clippings, leaves and other yard waste into our storm drains. This includes "sweeping" grass and leaves into the street with leaf blowers as they eventually wash down the drain. Why is this a problem? Yard waste can block the flow of water and lead to flooding. Decomposing grass and leaves deplete the oxygen in the water which can stress fish and other aquatic life.

Never place or <u>allow</u> anything to go down the storm drain. This includes cigarette butts, trash and even newspapers. Intentionally pouring paint, motor oil, antifreeze, pesticides, fertilizers, pet waste, litter, etc. into the street gutters or storm drains can affect the water quality of waterways and lakes, is dangerous to the environment and is ILLEGAL.

If you see anyone dumping any contaminants, yard clippings, leaves, etc. into the drain, please call the Pecan Grove MUD Customer Service (281) 238-5000.

Drainage Improvements to serve Victoria Garden Drive

The District is replacing undersized storm sewer from intersection of Victoria Garden Drive and Old South Drive to outfall into Bullhead Slough. Construction expected to commence in 4th quarter 2019.

Levee Drainage Improvements adjacent to Harvest Green

The District is working with the developer of Harvest Green to improve the drainage of the outside toe of the levee within the Harvest Green development. Drainage and grading improvements include grading improvements to ensure that the Harvest Green community drains away from the levee as well as new and clearly defined drainage swales to drain any rain that falls on the levee away from the toe.

Phase one of the project has been completed with Phase Two expected to commence construction in October 2019.
