### 6. REPORTS AND CORRESPONDENCE

- a. Chairman's Reports
  - Mr. Bourne reported the great turnout for the Labor Day Auxiliary Event and asked that appreciation
    and recognition be shown to the Auxiliary as they work hard and provide needed equipment for the
    District.
  - Mr. Bourne and Ms. Hawke attended a Special District Meeting in Flagstaff for the purpose of creating
    ways to help Coconino County Special Districts (Fire, Water, School) to succeed. As a result, many
    valuable County connections (County Assessor, County Treasurer, Clerk of the Board of Supervisors,
    County Attorney) were made.
  - Mr. Bourne noted that BRFD Board of Directors election will be on the November 8<sup>th</sup> General Election ballot. There are four people running for three positions. This participation shows the community support for the Fire Districts, as all current Board Members were appointed. We appreciate the community support and ask everyone to vote.

## b. Chief's Report

I. Personnel 36 personnel: 14 Volunteers, 14 Reserve, 6 Full Time and 2 Part Time

II. Apparatus Medic 3 received new tires; Engine 14 received all necessary repairs. All Apparatus are in service.

## V. Updates

- Chief Paine updated the Board regarding PSPRS refunds being received by our former and four full time employees regarding overpayments made into the system. The District will be reimbursed for these refunds through Contribution Credits. This is a result of a PSPRS glitch and not of the District.
- Chief Paine advised that the District was in the midst of the 2021-2022 Audit by Saunders Company,
   Ltd. This is the final year of their three-year contract. This process is moving smoothly.
- Chief Paine attended the Arizona Ambulance Association Conference in Tucson and a regional Cardiac Resuscitation Symposium in Phoenix this past month.
- Chief Paine reminded us about Proposition 310 that will be on the November 8<sup>th</sup> ballot which is a sales tax that would generate \$150M for Arizona Fire Districts. The tax translates to \$10 spent = .01 cent or \$100 spent = .10 cents to Arizona Fire Districts. He encouraged all to learn about it.

#### 7. CALL TO THE PUBLIC

Mr. Meakin asked how the funds from Proposition 310 will be allocated. Chief Paine said the funds would be allocated to the 144 Arizona Fire Districts by size.

Proposition 310 will be a "stand alone" item on the ballot and not contained within any other ballot item.

Mr. Bourne asked for a Motion to discuss and possible action to review and approve Policies. Ms. Hawke made the Motion; Ms. Varns seconded. All voted yes.
