The Service Department has been working alternate days in order to keep social distancing. The Fire Department is using the Senior Center as a second facility to run an ambulance squad from that location in order to separate personnel and prevent contamination. All employees are taking temperatures at the start of each shift, and cleaning and sanitizing continue on a daily basis.

based on what our federal and state leaders implement to try and stop the spread of COVID-19. All of Lake County's Mayors and Managers have a conference call twice a week to try to stay current on the outbreak and the ever-changing mandates from our state and federal governments. Many times they are vague and need more interpretation. We continue to ask if the pools and day camp will be allowed to open this summer with no real response. We also do not know whether or not little league baseball and other sports will be playing this summer. To proceed to open pools is a major task. We need to make sure that we have enough lifeguards and pool chemicals. With these uncertain times, many of our seasonal employees may take jobs elsewhere to be guaranteed a paycheck and not wait to find out if the pools or camp will eventually open. I hope for the best and a plan to move forward.

As of April 22, Willowick had a cumulative six positive cases of COVID-19. Lake County has had a cumulative 157 positive cases. This is from the start of the outbreak. There have been seven deaths in Lake County total due

to the COVID-19 virus with one of those being in Willowick. I can report that for the first time since tracking began, there were no new cases reported on April 26. Let's hope this trend continues.

All companies have had to make changes in how they do business, and Kimble is no exception. Keith Kimble contacted me in early April and indicated that he didn't know if he would be able to maintain the staffing levels to collect trash, recycling material and yard waste. For two weeks they provided 10 dumpsters at the Community Center for yard waste drop off and asked that resident wait on bulk items. They were diligent in picking up those dumpsters whenever we called, and everything ran smoothly compared to other cities that were going through the same situation. As of April 27, Kimble is back to picking up all material curbside as normal. Thanks to all the residents that made this a smooth and neat transition and for following the rules.

I have seen several good things during this crisis that make me proud to be from Willowick. I have seen many families walking and spending time with each other, and while doing so picking up trash (a lot of gloves) along the way. I have even had pictures

sent to me of problem areas that enabled us to notify owners to clean up or enable people to take care of leaking sewers because more people were out walking and being part of the city. Our Service Department has been able to get to projects and things that were typically put on the back burner because we were short of time or people.

Postal Food Drive Postponed

It is with great sadness that I have to report that the 28th annual Letter Carriers' Stamp Out Hunger Food Drive, scheduled for May 9, 2020, has been postponed. The NALC, as well as our national partners, are fully committed to rescheduling the food drive later in 2020. A new date has not yet been scheduled.

The annual success of the food drive is largely due to the efforts of letter carriers, other postal employees, postal customers, community volunteers and many more. Their safety is of utmost importance. As of this writing, much of the United States is currently under shelter in place or similar advisories due to the COVID-19 pandemic, and public health authorities such as the Centers for Disease Control and Prevention (CDC) have issued guidelines that include social distancing. While it is unknown

how long these guidelines will remain in place, we will keep people posted with updates as soon as it is known when we can safely conduct this Food Drive.

While we may not be able to safely conduct the food drive on its traditional date, we encourage those that would participate to consider donations that may be safely made to food banks in the form of food or financial assistance. Bankruptcy 101:

The world changed in a day. Fortunes were lost in an hour. Financial security was exchanged for terror. A 2017 report by the employment website CareerBuilder found that seventy eight percent of American workers were living from paycheck to paycheck. Even if we could all get out there is no job to go back to. The bills will not stop. At some point, the utility companies will be able to disconnect service, the cost of food will skyrocket, collection activity/harassment will increase dramatically and so will stress caused illness. If you are one of the many people, whose bottom is about to fall out there is still hope. Do not allow yourself to lose your health (or, maybe, even your life over financial stress) because if that happens you will not be able to fix your life. The Importance of Advance Directives

I am not an attorney so please do not mistake this for legal advice. However, I believe everyone should put their health care decisions in writing and select a person to act on their behalf, just in case they are ever unable to speak for themselves. You can do this by preparing a set of formal documents referred to as Advance Directives stating

your wishes. In most cases, your Advance Directives will include:

A **Living Will** which states what life sustaining medical treatments you would want or refuse if your life is in jeopardy and you are unable to express your wishes.

A **Health Care or Medical Power of Attorney** or **Durable Power of Attorney for Health Care** which names a specific

person to represent you. This document gives this person the rights to:

- Make medical decisions that are not covered in your living will
- Enforce your healthcare wishes in court if necessary
- Hire and fire doctors and medical workers overseeing your treatment
- Access medical records
- Provide visitation rights

Your representative cannot contradict the terms of your Living Will. Also, a physician and a second doctor must both conclude you are unable to make your own decisions before the Medical Power of Attorney goes into effect.

Once you prepare your Advance Directives, it will be up to you

to share these documents with your family, your medical team and those who will be entrusted to carry out your directives. Directives can be revoked or replaced at any time as long as you are capable of making your own decisions. It is recommended that you review your documents occasionally to ensure that they continue to accurately reflect your wishes.

You can download Advance Directive forms online or contact your local office on aging, your state health department or an attorney to learn more.

No one wants to envision a time when they are unable to make their own health care decisions. But, having your Advance Directives in place offers some assurance that there is someone you trust who will do the best to honor your wishes.

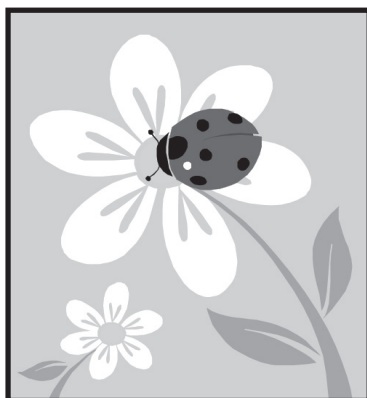

that half of the city. The Service Department has been working split shifts and the Building Department is now working from 8 to 12 Monday through Friday. These steps have been taken in order to maintain less contact among our employees.

It is critically important that we all follow the CDC guidelines during this time to protect the health of all our fellow citizens.

As of Monday, April 13th. Kimble has temporarily suspended yard pick-up as a result of the COVID-19 pandemic. Ten dumpsters are available at the Senior Center's (321 E. 314th Street) north parking lot from Monday-Saturday, 9:00 a.m.-3:30 p.m. for Willowick residents to drop off their yard waste. Traffic flow will be one way in and one way out in order to practice social distancing. This service is for Willowick residents only and is only for yard waste. No plastic bags, trash, bulk items, appliances or commercial vehicle yard waste will be accepted. Acceptable items include biodegradable paper yard waste bags containing yard waste, leaves, grass, vegetation, tree trimmings not exceeding 4 feet in length and 6 inches in diameter. Branches do not need to be bundled. There is no charge for this service.

City Council passed the 2020 budget at the 3/18 Council meeting as required by State law. Due to the current health crisis, Council decided to vacate the April 7th and the May 5th meetings however did have the 4/21st meeting remotely.
