### What is Christmas in April?

Christmas in April St. Mary's County, Inc. is an all-volunteer program in which volunteers work together the LAST SATURDAY IN APRIL to repair the homes of low income, elderly and disabled homeowners.

## Who is eligible?

Low income, especially the elderly and/or disabled residents of St. Mary's County who own their home are eligible.

## What types of repairs are done?

The work varies from house to house. Repairs may include plumbing, carpentry, electrical and general repairs, as well as yard clean up and trash removal. Non-working furnaces, hot water heaters and appliances may be replaced.

### How are homes selected?

Our process starts with an application that is available on our website, at the local senior centers and libraries or by calling 301-884-2905. A member of the House Selection Committee along with a representative from skilled labor make a site visit to determine the homeowner's eligibility and the feasibility of the repairs.

## **HOW CAN YOU HELP?**

#### **Contribute cash:**

We accept tax deductible contributions from individuals and organizations in any amount. You may wish to sponsor a house for a set donation.

#### **Provide your expertise:**

We need skilled tradespeople, such as electricians, plumbers, carpenters, roofers, landscapers and painters.

## **Donate materials and supplies:**

Paint, paint accessories, fencing, doors, cleaning supplies, plumbing and electrical supplies, drywall, office supplies, etc. are always welcomed from dealers, manufacturers, and companies. Christmas in April St. Mary's County, Inc. also requires the assistance of support services such as printing, and promotions.

Devote your time for one day:

No special skills are required. Anyone 14 years of age or older can volunteer.

The amount of people that worked on my house the last Saturday in April was amazing, to see so many people that I didn't know and they knew nothing about me, come to my house to help our family in need. You helped me to fix my furnace in the fall and it was the first time in four years of having heat in the winter and not using a kerosene heater! I didn't have to set my alarm to get up in the middle of the night to check to make sure there was fuel in the heater.
