Robert Wysong is the President and Chief Investigator for **ACS Investigative Services**. **ACS** was founded by Robert Wysong on February 1, 1991, after being employed for six years with a large insurance investigations company. He specializes in fire and fraud investigations on behalf of companies and organizations handling property damage claims. He has a full range of experience in all types of investigations including background, fire, burglary, auto thefts, and activity checks. He is certified by the National Association of Fire Investigators as a Certified

Fire and Explosions Investigator. He has been qualified and has testified as a fire causation expert in local, state, and federal courts throughout Missouri and Illinois. Robert is licensed in Illinois as a Private Detective through the agency license held by **ACS Investigative Services**, along with Tennessee, Kansas and Indiana. He is a long time member of the Missouri Chapter of the International Association of Arson Investigators, and the Professional Fire and Fraud Investigators of Missouri.

Prior to his career in the insurance industry, Robert held the position of Detective Sergeant with the Jefferson County Sheriff's Department, in Hillsboro, Missouri. He was the first Criminal Arson Investigator in the County's history, and was responsible for organizing the Jefferson County Arson Task Force. During his tenure with the Sheriff's Department, Robert attended the Jefferson County Law Enforcement Academy, along with several schools and seminars by the Professional Fire & Fraud Investigators Association, and the Missouri Chapter of the International Association of Arson Investigators. He has also attended several Kinesic Interview Techniques Seminars.

Robert's deep commitment to the investigation of fires came from his early exposure to a local volunteer fire department. He became a volunteer firefighter with the Hillsboro Fire Protection District in 1973. He attended fire schools and seminars sponsored by the local Jefferson County Training Coordinates, and the Fire and Rescue Training Institute, a division of the University of Missouri - Columbia. His thirst for education and training landed him a position as the Chief Training Officer with the District. During the period between 1977 and 1980 he became a part time instructor for the Fire & Rescue Institute, and taught fire related classes throughout the southeast part of Missouri.
