**KCBS JUDGING PROCEDURES WILL APPLY**  
*(based on appearance, taste and tenderness)*

**FUELS: Wood, Charcoal, Wood Pellet, Gas or Electric**

**RIBS: Any pork rib and open garnish**

- Teams are required to submit a minimum of six separate ribs (must be cut apart) in a 9 by 9 standard container.
- Teams will receive two 9 by 9 containers: 1 for judging; the other we are asking if you would kindly help out by putting leftovers in the second box (*we want to make sure we can keep our charity judges coming back - Thanks for your help!!!*).
- There is a mandatory team meeting 9:00 am Saturday morning at the judging tent.
- Meat will not be inspected. Meat can be marinated or seasoned ahead of time but must not be cooked in any way.
- Cooking may begin after arrival; meat must not be removed from a team's area until turn-in.
- Only one submission from each team area is allowed.
- Teams must not share cooking equipment.
