Please note that lunch is non-refundable. Please sign up before the month starts. If you forget your child's lunch the school will charge you \$8.

Challenge School Payment Policy

Security Deposit: \$1500 per family

For current students:

- 30 days advance written notice is required to receive full refund of deposit (with the exception of those that withdraw between April 1st and August 31st.)
- Students who are withdrawn between April 1st and August 31st will receive half of the security deposit with the exception of those who submit written notification on or before March 31st.

For new students:

- **Deposit, Material Fee, and First month tuition are due when space is confirmed.**
- If withdrawn before the starting date with a 30 days' notice, deposit will be refunded. First Month Tuition and Material Fee will be forfeited.

Payment Policy:

- Full Payment due 1st of the month
- \$20 Late Fee will be applied after the 7th of the month
- \$30 returned check fee will be applied

Vacation Policy: There is an option to take 2 weeks off in summer (See 8 weeks Summer Session). Other than that, tuition is due every month. Tuition will not be prorated due to illness, absence, any type of emergency, or vacation.
