Tournament Rules

- 1) Bowlers are eligible to participate in this tournament if they have paid their 2018-19 USBC Membership dues thru the Greater Baltimore USBC Association (either full membership at \$23 or co-association at \$9).
- 2) Entrants shall use their highest GBUSBCA average for the 2017-2018 season. If no GBUSBCA yearbook average for the 2017-2018 season, entrant shall use their highest GBUSBCA current average for at least 21 games as of January 1, 2018. If the entrant also has a non-GBUSBCA average listed on bowl.com, their highest bowl.com average for 2017-2018 will be used for their entering average. Otherwise, entrant shall use an average of 210. If using the current season's average a written verification of this average, signed by the secretary, must be provided to the tournament director prior to the start of bowling.
- 3) Prize fund shall be returned 100%. Prize ratio shall be at least 1 in 10 for each event.
- 4) Unlimited multiple participation is permitted. USBC Rule 315 applies.
- 5) If a bowler has entered an event by the closing date for entries, they can enter that event again based on lane availability.
- 6) No more than two PBA Members shall be permitted to bowl on a five person team while no more than one PBA member shall be permitted to bowl on a doubles team. A violation of this rule will result in disqualification.
- 7) USBC Rule 319a(2), ten pin up rule, will not apply.
- 8) USBC Rule 319d applies. Entrant must report (in writing) all prizes which they have qualified for within the last 12 months to tournament management prior to bowling. Failure to comply may result in forfeiture of entry fees and prize winnings.
- 9) USBC Rule 319c (Rerating) applies.
- 10) Team captain shall check in their team and present USBC Membership Cards for all of their team members at least 30 minutes prior to time they are scheduled to bowl.
- 11) USBC rules applicable to sanctioned tournaments apply when not specifically covered by these rules.
- 12) The Tournament Director shall decide any questions not specifically covered by these rules.
