

Hiddenbrook ARC Updates Coming Soon

The Hiddenbrook Board and Architectural Review Committee have been working on a significant revision of the architectural guidelines. The Board has sought to add clarification to the rules to reduce ambiguity and enable consistent application. In addition, it proposed to allow concrete driveways, increase the maximum size of detached structures and re-introduce a color palette.

The draft version of the document is now complete and we are seeking input from the community on the proposed changes. The guidelines will be posted on the Hiddenbrook Homes website from 2/1/2023 for a period of 45 days. Written feedback from the community will be collated on a weekly basis and posted on the Hiddenbrook Homes website. Homeowners should send their feedback to Chelsea Miller (Sequoia Management), <u>cmiller@sequoiamgmt.com</u>. Homeowners should provide their name and address with their feedback; anonymous feedback will not be posted.

After the written review period, a Town Hall meeting will be held to discuss the feedback and seek additional verbal comments. The date and time of this meeting will be announced in March.

Bamboo Ordinance Now in Effect

Effective January 1st, Fairfax County's new running bamboo ordinance calls for property owners to get the invasive grass species under control and imposes civil penalties on property owners who let it "spread to adjacent properties or any public right-of-way."

The ordinance was approved by the Board of Supervisors back in March 2022, along with a fine structure that includes \$50 for the first complaint or violation, \$200 for subsequent violations, and a \$3,000 cap on fines over a 12-month period.

The county has set up a <u>webpage</u> to advise residents on the best methods to contain, prevent overgrowing, and dispose of bamboo.


