

A reminder that payment for memberships sold should be made to Maryland PTA (\$3.75/member) and to HCCPTA (\$.50/member) by the end of each month. We still have local units who have not submitted dues for membership to HCCPTA for the 2011/2012 school year. Don't get confused. Pay them at the same time. Please do not pay Maryland PTA for any membership that you do not sell as they do not issue refunds. You must remit your membership dues promptly. Not reporting to Maryland PTA or HCCPTA the portion of the dues you collected on their behalf is withholding money that rightfully belongs to them and is considered fraud by IRS.

Treasurer's Responsibilities

All local PTA units were required to complete one of the 990 forms for the IRS. This should have been submitted to the IRS by, in most cases, November 15. Local PTAs are also required to register, or annually renew their registration, as a charitable organization with the Office of the Secretary of State and have submitted the fee, if appropriate, by the end of December. Those locals who filed the e-postcard for the 990N will not have to pay the fee, but Maryland PTA has determined that you must register with the Secretary of State.



According to Maryland PTA Bylaws, you are required to submit the treasurer's annual report reviewed by an auditor or an auditing/review committee to Maryland PTA annually. The Standards of Affiliation report that HCCPTA receives from Maryland PTA shows very few reviews/audits have been received from Harford County locals. Be watchful for the 2012 Personal Property Report forms which should be in your school's mailboxes in late January or early February. These are mailed to organizations that have not forfeited their incorporation in the state of Maryland and have a return due date of April 15. In order to maintain your good standing with Maryland PTA, you must submit a copy of that report to Maryland PTA. You can view your status by searching the website of the Department of Assessments and Taxation at <u>www.dat.state.md.us</u>. If you have forfeited your incorporation, contact Maryland PTA.

If you need to submit an IRS 1099 MISC for those individuals for whom you paid \$600 or more last <u>calendar year</u>, you should have ordered this form and the accompanying IRS form 1096 remittal form as the 1099 must go to the individual before the end of January. This form is not downloadable so order it immediately. Penalties for late reporting to individuals are quite stiff. Check MDPTA website <u>Cash Encounters</u> to determine who qualifies.

Now is an excellent time to review your budget to see if any amendments are necessary. Remember that IRS requires that you use a gross budget. This means that you cannot only report the profits from your fundraisers as income.

Avoid Common Bylaws Pitfalls

• When it is time to review your bylaws, most people get all worked up and their eyes glaze over. Bylaws are not that scary or daunting if you just take your time and avoid some common pitfalls.

• The most common mistake people make is by trying to change the standard form language. Bylaws are mostly boilerplate language that cannot be changed. Yet people still try to change it. This is when your bylaws will be rejected by the Maryland State PTA.

• Your duty when completing the bylaw review is to make sure all the blanks are filled in. Forgetting to do so is another common mistake. If you have left any of the blanks empty, your bylaws will be rejected.

• Make sure when you review your bylaws, you have a committee reviewing them. This helps to make sure everything is double and triple checked. That way, when you present the bylaws to your general membership, there should not be any mistakes.

• There are some common things to look for. If you have more than one vice president or secretary, you must make sure to add what each person's specific duties are as the template only includes duties for one vice president and one secretary. If your terms of office are two years, you need to add whether elections for the position are in odd or even years. If the positions are only one year, this is not necessary.

• When you complete the information on the back of the bylaws concerning who to contact in case there are any issues, make sure you think carefully who to use. If you are reviewing bylaws toward the end of the school year, you need to make sure you put an officer that will presumably be at the school the next year since it is likely the review may occur over the summer. If you put, for example, a President who is leaving the school because his or her children are moving on, that person may not be available to handle any questions the Maryland State PTA Bylaws Committee may have. Instead put another officer that you know will be returning.

• Maryland PTA changed the bylaw templates so make sure that you are using the most recent version. You will also need to include a copy of the minutes from the meeting in which your PTA adopted the bylaws, even if there were no changes.


• When it's time to review your bylaws, don't panic! They are not as bad as you think if you just take your time and "fill in the blanks".

Your Harford County Council PTA understands that it is often difficult for local PTA leaders to come to our meetings, so we are making plans to visit all 48 of the PTAs in the county this year. Think of it as HCCPTA on wheels!

HCCPTA Betty Bull Scholarship Award

Since 1988, the Harford County Council of PTAs has sponsored this award in honor of Mrs. Bull and her tireless and selfless efforts on behalf of children's welfare. She served during the 1950s as National PTA Legislative Chair, Maryland PTA President, Maryland State PTA Legislative Chair, President of HCCPTA, and President of the Jarrettsville Elementary PTA. She was also President of the Maryland Council on Education following World War II. She died on November 13, 1990, at the age of 86. The Harford County Council PTA continues this Award Program in her memory.

All Harford County High School Seniors with a GPA of at least 2.0 and a valid PTA/PTSA membership from any one of the 48 Harford County PTA Schools is eligible to apply for the Betty Bull Award.

Betty Bull Award application deadline is April 2, 2012

The Harford County Council of PTA. Inc. is planning to award up to four (4) \$500.00 scholarships for the 2011/2012 school year. (The number awarded is dependent on available funding from HCCPTA membership dues.)

The purpose of this award program is to provide financial assistance to students of the Parent Teacher Student Association who are pursuing their goal toward advanced education. All Harford County high school graduating seniors are eligible. There is a stipulation that the student or a parent or guardian is a member of a PTA or PTSA in Harford County.

Applications can be secured from the High School Counselor's office and are available on our website: www.hccpta.org.

Eligibility:

- 1. Must be a senior in a Harford County public high school.
- 2. Must have applied and been accepted at a post secondary institution, e.g. college technical school, etc.
- 3. Must have achieved a minimum GPA of 2.0.
- 4. A copy of the student's PTA/PTSA membership card, the parent's or legal guardian's PTA/PTSA membership card, or the signature of the President of a sponsoring PTA/PTSA only must be provided with this application.
- 5. Money awarded by the scholarship must be used for tuition, transportation, books and other associated materials, room and board to a college or technical school.

Selection Criteria: (Rating for Award applicants is based on a scale of 100%.)

- 1. Goals (40%)
- 2. Volunteer work/Extra curricular activities (30%)
- 3. Grades (GPA counts as 10% of the final process)
- 4. Written application (10%)
- 5. Letters of Reference (5%)
- 6. Financial need (5%)

Procedure: Complete the three-page application. Verify that all material is included or being submitted.

SUPPORTING MATERIAL REQUIRED:

- 1. Completed three-page application form by the deadline.
- 2. Transcript of high school credits earned, including current semester and GPA.
- 3. Two letters of recommendation from teachers, employers, sponsor, etc. (Family members may NOT be included as references.)
- 4. Copy of PTSA or PTA membership card or signature of only a PTSA/PTA President.


News from Youth's Benefit Elementary School

Promoting Math for Kids of All Ages by Dr. Rick

Math is in the news again. The White House is promoting math education with superstars like Sesame Street's Elmo, and in Maryland, the state where I live, the University System is developing new math requirements for students headed to state colleges and universities. Those new requirements include four years of math studies in high school instead of the current three. Other states are no doubt doing the same.

Many students complete three years' math study by the end of their junior year and don't bother with math in their senior year. That's a one-year hiatus until college. You can forget a lot in one year. Four years of math study will better prepare students for university or work in our increasingly science-technology-engineering-math oriented economy.

Do we do enough to get kids interested in math at an early age? Probably not. Here are some thoughts and tips.

- 1. Look for numbers all over. For the youngest learners, look for numbers all around the house and the neighborhood. Just as we look for letters and words as our youngsters are learning to read, why not "explore" for numbers, too? There they are in magazines, on the addresses outside our homes, in road signs. Combine words and numbers in "searches," and see how fast children catch on.
- 2. **Use numbers**. Let your child punch in the numbers when you're making a phone call, read the quantities in a recipe, dial the oven to the necessary temperature (with your supervision, of course). Let her set the alarm clock, set all the clocks at spring-forward, fall-back time, and help you monitor number-exhibiting gauges like thermostats, speedometers, odometers, tire-pressure gauges, and the like.
- 3. **Count**. There are lots of things you can count with your youngsters. Stairs, birthdays, family members, cars in a small parking lot, toys on the floor, toys on the shelf, "sleeps" until a happy occasion, pets in the neighborhood. Sing counting songs. "Ninety-nine bottles of beer on the wall" can be changed to "Ninety-nine bottles of juice." It's a better message, but fair warning it'll drive you just as nuts in the car.
- 4. Look for shapes and patterns. Helping kids recognize and notice shapes and patterns gets them ready for the rudiments of geometry. Rectangles, squares, circles, ovals, triangles, and other shapes surround us in our homes and neighborhoods. Patterns are organized, repetitive, and predictable and they're all around us. "Old MacDonald had a farm, E, I, E, I, O." Odd and even numbers. The seasons of the year. Rituals at church, temple, or mosque. Morning routines. Exercise routines. Recognizing simple patterns help children to predict what comes next.
- 5. **Know about STEM**. Science-Technology-Engineering-Math courses are more important than ever. For your middle- and high-school students, encourage them to explore these courses. Learn about them yourself so you can be a knowledgeable advocate at home.
- 6. **Be a role model**. Talk about the role of math in your life and job. Let the kids see you doing math. Point out your math when you're filling the car with gas, following a recipe, paying bills, examining sports statistics, figuring out the route for a vacation, building a tree house, figuring out a pool shot. If you "hated" math when you were in school, keep your mouth shut about it.
- 7. Advocate for good math teachers. Yes, all teachers are important, but math teachers are among the teachers hard to come by, more's the pity. So, let your principal know that you're interested in math education and you're willing to lend a hand when it comes to recruiting and retaining a new math teacher. If you have a college aged child who's good in math, encourage him or her to consider teaching.
- 8. Bone up on the curriculum. No, you don't have to master the higher math courses, but you should know about the math curriculum in your child's school. What are the requirements? What's the progression? Are the texts and materials up to date? Is special tutoring available? (The company I work for, Sylvan Learning, has an excellent math record for kids who want to catch up, keep up, or get ahead. Check us out at <u>www.SylvanLearning.com</u>. Sylvan Learning also offers SchoolMathPrep.com, a new, FREE, online math resource for grade 7-12 teachers and students to use at school for remediation, enrichment or test prep. To learn how your family can use SchoolMathPrep.com's sister site, SylvanMathPrep.com, during your family's homework time, visit <u>www.SylvanMathPrep.com</u>.)
- 9. **Have fun**. Kids don't need to know they're learning math. There are many, many games that enhance math skills. Card games, Scrabble (good for math patterns and vocabulary), puzzles, Sudoku, brain teasers, fun workbooks, and Monopoly, to name a few.
