

Ralston City Council Special Meeting

Tuesday, September 12, 2017

The Ralston City Council met in a special session on Tuesday, September 12, 2017 at 5:30 PM at Ralston City Hall. Roll was called with the following present: Konwinski, Fideline, Alberhasky, Krause, Sanchez, Preis and Mayor Groesser. The agenda for this meeting was available at City Hall for public inspection and posted prior to the meeting. The legal notice for the meeting was published in the Ralston Recorder.

Mayor Groesser said the meeting is subject to the Nebraska Open meeting Act and a copy of the Act is posted at the rear of Chamber.

Konwinski introduced Resolution 2017-4: A RESOLUTION AUTHORIZING USE OF LOTTERY FUNDS IN EXCESS OF INTEREST FOR PURPOSES OF PROPERTY TAX RELIEF. Mayor Groesser opened the Public Hearing for consideration of Resolution 2017-4. He noted that this resolution was needed to provide for funds to meet bond payments associated with the construction of the Ralston Arena. Funds for these bond payments also come from the Arena 779 Fund and the Restaurant Tax Fund. Public Hearing was closed. Krause moved to approve RESOLUTION 2017-4, seconded by Fideline .The vote: Yes, Konwinski, Fideline, Alberhasky, Krause, Sanchez, Preis,00, motion carried.

Mayor Groesser opened the Public Hearing for consideration of the proposed Budget Amendment. Closed Public Hearing. Krause moved to approve the Amendment of the Budget, Alberhasky seconded. The vote: Yes, Konwinski, Fideline, Alberhasky, Krause, Sanchez, Preis, motion carried.

Krause introduced ORDINANCE 1218, AN ORDINANCE TO ADOPT AN AMENDED BUDGET STATEMENT FOR THE CITY OF RALSTON; TO APPROPRIATE SUMS FOR NECESSARY EXPENSES AND LIABILITIES; TO PROVIDE FOR AN EFFECTIVE DATE. Public Hearing was opened. Public Hearing was closed. Krause moved to approve ORDINANCE 2018, seconded by Fideline. The vote: Yes, Konwinski, Fideline, Alberhasky, Krause, Sanchez, Preis, motion carried. Krause moved to waive second and third reading of ORDINANCE 1218, seconded by Fideline. The vote: Yes, Konwinski, Fideline, Alberhasky, Krause, Sanchez, Preis, motion carried.

There being nothing further of a general nature to come before the Council, the Meeting was adjourned.
