Following a motion by Mr. Arnold, seconded by Ms. Scully, it was VOTED (unanimously) to approve clarifications to the Point Schedule for the Miscellaneous Class to award "dogs defeated points" to the Best in Miscellaneous Class winner. The winner of the Best in Miscellaneous Class will be awarded points towards a Certificate of Merit based upon the total number of dogs that competed in all of the Miscellaneous Class Breeds.

This should help the people who have one or two Portuguese Podengo Pequeno and no one else close to them get the points they need to obtain a CM title.

AKC Rules Applying to Dog Shows Amended to July 2010

SECTION 23. The Miscellaneous Class shall be for purebred dogs of such breed as may be designated by the AKC® Board of Directors. No dog shall be eligible for entry in the Miscellaneous Class unless the owner has been granted an AKC identification number, and unless the AKC identification number is given on the entry form. Application for an AKC identification number shall be made on a form provided by the AKC and when submitted must be accompanied by a fee set by the Board of Directors.

The regular Miscellaneous Classes for each breed shall be Puppy and Open, with the same eligibility requirements in Sections 4 and 10 of the Chapter respectively. These classes shall be divided by sex. All class winners within a breed shall compete for Best of Breed and Best of Opposite Sex to Best of Breed. Each of the Miscellaneous Class Best of Breed winners shall be eligible to compete for Best in Miscellaneous Class. All entries for Best in Miscellaneous Class shall be made after judging of the individual Miscellaneous breed classes and no entry fee shall be charged. In the event that the owner of a dog designated Best of Breed shall not exhibit the dog in the Best of Miscellaneous Class Competition, no other dog of the same breed shall be allowed to compete. There shall be no further competition for dogs entered in the Miscellaneous Class.

Winners of the Best of Breed and Best of Opposite Sex to Best of Breed in each of the individual miscellaneous breeds will be awarded points towards the Certificate of Merit (CM) title based on the number of dogs competing. (BOB receives the points for total number of dogs entered in the breed- and BOS receives the points for the total number entered of that sex. -Mari-Beth O'Neill) Upon completion of the CM title a dog may continue to compete in the Miscellaneous class so long as they are of an eligible breed.

The CM suffix title is an introductory title to AKC conformation events and will be superseded by the CH title when earned (October BOD Meting - the CM title will now be retained). The **Certificate of Merit requires 15 points** awarded in accordance with the following point structure:

The ribbon shall conform to Chapter 5, Section 2 of these rules and shall be the following colors:

- First Prize Rose
- Second Prize Brown
- Third Prize Light Green
- Fourth Prize Gray
- Best of Breed Orange
- Best of Opposite Lavender
- Best in Miscellaneous Pink and Green

At present, the Miscellaneous Class is open to the following breeds: Portuguese Podengo Pequeno (eligible as of 01/01/2011)

Happy Spring!

The first few months of 2011 have been very active, with the long-awaited debut of our beloved Portuguese Podengo Pequeno in AKC Miscellaneous Class. Now those who participate in Conformation can join all of you who have been enjoying the AKC Companion events for the past few years. *PPPAmerica* member Sue Davis & Spanky led the charge by being the first PPPequeno in the AKC conformation ring at the Greater Daytona Dog Fanciers Association, Inc. in Florida on Jan. 7th. Spanky was Best of Breed & also went Best in Miscellaneous Class -- go Sue & Spanky! "Parabéns" also to his breeder, Antonieta Rodrigues of Monte dos Podengos in Portugal.

That first weekend there were entries at several shows around the country, many more "firsts" and lots of excitement. The 1st Certificate of Merit title for the breed was earned on Feb. 12, 2011 by Broken Road Show Me the Bunny, better known as Harmony — well done Susan & Stacy Faw & Pat Reisert!! The impressive participation continues all over the country with approx. 175 bitch and 90 dog entries to date (March). That is more entries than all other Miscellaneous breeds combined!! Yeah!!

Congrats to everyone who has been part of this tremendous effort! The reception for the breed has been very positive, with many more people falling in love with them at every appearance. Keep up the good work!

As more people become familiar with the breed we see more "podengos" listed at shelters. Of course these are unlikely to be pedigree dogs, but since so many mixtures look somewhat "podengo"- like, some owners of these dogs contact us hoping that there new darling is a PPPequeno. Over the years when I have received these enquiries, there were few enough registered dogs in the country, I knew where they all were and so it was relatively easy to ascertain that it wasn't one of them. However, as we get more in the US and there are more breeders here, it is critical that breeders microchip their puppies. A good idea is to use the kind that also come with pre-paid registrations and list yourself as secondary contact. Even though we all strive to place puppies in homes that will remain in touch with us for the lifetime of the dog, and have as part of our contracts that the new owners should contact us first if they ever have to re-home the dog, on (hopefully) rare occasions the new owners do not. Micro chipping will ensure that you'll get a call if the owner cannot be reached ensure that it's always possible to identify dogs of your breeding and reunite them with their owners.

PPPAmerica has some AKC- CAR microchips available at cost as a benefit of membership. They are the ones that can be read abroad, so when you go to compete at shows such as Monografica or Crufts, microchip incompatibility won't be a problem © Find details on page 28 in the newsletter.

Also, for those of you interested in going to Portugal for the Monográfica, while we're still awaiting final confirmation of the date, it appears it will be the weekend of June 18 -19 in Caldas da Rainha, which is about an hour north of Lisbon and in a very nice region for touring. Details, when finalized, will be posted on the Portuguese Club website http://clubedopodengoportugues.com/

And finally, don't forget to mark your calendars for the National Specialty on October 22nd Join us for a wonderful multi-day canine event in beautiful Pleasanton, CA. I hope to see you there!

Sixteen year old BreAnna Ehlers has been immersed in the dog world since she was six years old when her nana, Dee Hinkle, introduced her to her first Havanese. Since then, Bre has been a co-owner, breeder and handler for the D'Va Havanese and Chinese crested, winning in both the breed ring and Junior Showmanship. Her most



exciting achievement was being one of 12 finalists out of 165 Juniors at the 2009 Eukanuba competition. More recently Bre and Dee have become intrigued with the charming Portuguese Podengo, and she added membership in this breed club to her memberships in the national Havanese Club and the local Grand Island Kennel Club.

In the past year, Bre has been writing a monthly column for the Grand Island Kennel Club's newsletter entitled "A Junior's Perspective". Club members have enjoyed reading about Bre's experiences and thoughts on the dog world, and now her column has garnered national attention. The Dog Writers Association of America sponsors an annual writing contest and each year hundreds of published writers enter their best in the hopes that their peers will recognize their talents with a nomination to the finals. This year Bre's column was nominated by her editor, was judged by three national judges against otherwise adult competition, and has now achieved the coveted finalist status. In addition, Bre has also been nominated for Best Junior Writer. The awards ceremony will be in New York City the night before Westminster, but even if Bre doesn't win the top "Maxwell Award", being a finalist in this prestigious national contest is accolade enough.

Bright, lovely, talented, and downright nice, Bre Ehlers is the kind of young lady that the dog fancy needs in order to thrive in the future. Whether it is Havanese or Podengos, Bre will certainly continue making her mark in the ring as well as in the hearts of all who know her.

How the Portuguese Judge the Portuguese Podengo Pequeno

Now that the Portuguese Podengo Pequeno is showing in the AKC Miscellaneous Class, many judges and fanciers are eager to learn more about this delightful breed. What better way to do so than from the breed experts in Portugal, the Country of Origin?

During my 10 years of involvement with the breed, I have been fortunate to make countless trips to Portugal to observe these dogs, learn from the breeders and hunters, and ultimately show and title dogs of my own breeding in Portugal. While there is no substitute for learning this way, and I highly recommend it to anyone seriously interested in the breed, the goal of this short article is to share some essential insights from those who know the breed best. This will assist Americans as they "meet" the dogs in the AKC show ring for the first time, and should be a valuable resource to exhibitors in answering the many questions that PPPequenos generate at a dog show!

For the purposes of this article, I asked several of the most prominent Portuguese experts to share key points about the breed for the benefit of US judges and fanciers. This is a composite of information shared by Vitor Veiga, Carla Molinari, Rui Oliveira, and Gabriela Veiga., with editing for AKC phrasing by John Fitzpatrick & Suzanne Faria

The Portuguese Podengo Pequenos of America (PPPAmerica), has worked with Vitor Veiga, President of Podengo Club of Portugal (CPP) and Carla Molinari, President of the Portuguese Kennel Club (CPC), to ensure the USA standard, while re-written by PPPAmerica to include only the Pequeno, and in the terminology and format used by AKC judges, has the same substance, describing the same ideal dog as does the current Portuguese/FCI standard (Note: New FCI standard dated November 2008).

TYPE is the most important aspect of the breed. The total dog must be judged against the standard. There is no one aspect more important than the total Podengo Pequeno essence possessed by the dog. Having correct type is paramount.

The PPPequeno is a rustic ancient hunting breed. It is a primitive hound. It is not a flashy dog. It is a dog of moderation. It may remind you of a terrier, but is NOT and should not have terrier type.

As a hunting breed, the coat is natural. The smooth coat is short, dense, without undercoat, and no grooming is necessary. The wire coat, also without undercoat, is of a hard texture. It is, however, an open wire coat, and stripping is NOT to be done. A good combing is all that is necessary to remove any dead coat. No scissors or clippers should ever be used on the dog's body. In some wires, longer hair growth is seen on or inside the ears and sometimes also on the neck. This can be removed by plucking. One of the many reasons people are attracted to the Pequeno is because of the minimal grooming required.

The height the standard calls for is 8-12 inches. Judges are encouraged to look for the most balanced dog with good Pequeno type within this range. Occasionally one encounters a dog of larger size, but one must weigh the need for correct type within the size range. What is not helpful at this point in time is a too serious emphasis on height, as this, consciously or unconsciously, places more emphasis on this one attribute of the dog. It is better to have a dog slightly over sized that is balanced, than one that is within the breed standard but is not displaying Pequeno type. It is a question of common sense. Needless to say, a judge will recognize that a dog that is excessively oversized should not be awarded Best of Breed.

Another essential component of type is the correct body proportion, without which the dog lacks correct PPPequeno type. The length of the body should be 20% longer than the height to the withers, (or 6:5 proportion as it states in the FCI standard). This in combination with the height proportion of the distance from the withers to the bottom of the chest being half of the total height gives a rectangular dog that is slightly longer than tall, bred to effectively bred to maneuver through thickets to get at its quarry. Proper proportion allows them to turn quickly as mandated by their prey in order to achieve a successful hunt.

In summary, PPPequeno TYPE supersedes everything. It is THE most important criteria on which to judge this breed.

Vitor Veiga is a breeder, hunter, and exhibitor of Podengos who is also an International Judge. He has been President of the Clube do Podengo Português (CPP, Podengo Club of Portugal) for 22 years. He is the author of the definitive book on the breed, The Portuguese Podengo.

Carla Molinari has been involved with purebred dogs for 45 years. She is a long time breeder of many breeds, including her beloved Portuguese Podengo Pequenos. She is well known as an International All-Breeds Judge and has been President of the Clube Português de Canicultura (Portuguese Kennel Club) since 1985.

Rui Oliveira, a Pointer breeder since 1974, is an International All-Breeds Judge who has judged at major shows on every continent, including many World Dog Shows.

Gabriela Veiga has been a dog lover all her life, breeding and showing several breeds, including smooth coat Pequenos. She is also an International Judge.

Darlene Devaney has been involved in the breed, showing & breeding, since the beginning in the USA in 2001. She serves as President of the AKC Parent Club: Portuguese Podengo Pequenos of America,.
