- Show management reserves the right to limit duplicate booths or similar products. Book early
- An exhibitor will not use space for any purpose not shown on the contract without prior approval of management.
- Let's Rock 'n Roll MS Away reserves the right, at their discretion, to reject any item offered for sale. Failure to comply with a request from the Let's Rock 'n Roll MS Away to stop selling any item will result in the vendor being asked to leave immediately.

Hours of Operation: Sunday, June 28th, 2020 10:00am to 3:00pm

- All lessees must be set up and ready for business by 9:00am and take down at 3:00pm on Sunday
- Booth needing early set up/late take down MUST make arrangements with Car Show organizers by June 1st
- All lessees selling food must comply with all local Health requirements
- All lessees using Propane must comply with all Municipal and Provincial regulations
- All Electrical Wiring for self-supplied power must meet provincial standards
- Booth must be manned at all times (reasonable breaks understood). If not, show management has the right to dismantle booth or allow another exhibitor to use the booth space.
- All lessees shall not injure or deface the area or surrounding area. Lessees or their representatives shall not attach any materials or displays that are inappropriate. If such occurs, the exhibitor is liable for any clean up and or property damaged.

Use of Space:

- All demonstrations or promotional materials/activities shall be confined to the limits of the assigned vendor space.
- VENDORS WILL SUPPLY THEIR OWN TENTS, CANOPIES, CHAIRS, TABLES, BENCHES, OR SIMILAR DISPLAY SURFACES. Backdrop displays are permitted.
- All tents/canopies must be weighed down such as, sand bags
- All lessees are solely responsible for his/her own booth material and should insure against loss or damage.
- All property of the lessee is understood to remain in his/her care, custody, and control in transit to and from, and within the confines of the area.
