#### PHIL SCHORN WILL DEMO COLOR PENCIL PAINTING AT MARCH 20 MEETING

We have all played with color pencils as a kid, but an artist-grade color pencil contains a much higher degree of wax and pigment, and can produce rich, deep and luminescent color. If you've seen Phil's work you can agree that color pencil is certainly fine art.

# PUBLICITY AND WEBSITE CHANGES WORK TOGETHER

At our February 20 general meeting Chris Tanner, Ali Albakri and Phil Schorn (Corresponding Secretary, Publicity Chair and Webmaster) explained how our long-time use of newspaper publicity has become ineffective, and that we have moved in a new direction. Ali has now focused on getting our members to contact others outside the art league, and the LCAL.org website has become a convenient tool for doing that.

If members want to promote LCAL membership or an LCAL event they can simply use e-mail or social media to direct others to the appropriate tab at LCAL.org to find the facts, and then add their personal thoughts and recommendations. Our website makes this simple to do, and can be used to present something as specific as a piece of member art or a general as the direction and energy of the art league. Someone considering joining the art league, for instance, can be directed to the "Membership" tab on our website to find a link to our membership form. Better still, once on the website they can browse other tabs to get a very clear picture of what we are about, and also what's happening in the coming weeks and months.

Phil explained how the LCAL.org website has been updated to include a list of our current members along with their city of residence and the art media they use. This gives a more intimate view of our membership, and it allows members and prospective members to find others they can identify with and maybe share rides with.

In an important new development, the LCAL.org website list of members will soon be expanded to identify personal websites or other links that display a member's art. At our June general meeting Phil will show members how to create a simple website, or how to instead create and manage a page at LCAL.org to present their art. Phil will provide specific guidance at this meeting and will work with members directly if necessary.

### PLEIN AIR SATURDAY MARCH 25 IN DOWNTOWN LIBERTYVILLE

The LCAL Plein Air Group's next event will be Saturday, March 25 in downtown Libertyville, where there are three coffee shops near the train station if you need a break from the spring weather. One has some classy art on the wall.

Libertyville's downtown area was largely destroyed by fire in 1895 and rebuilt with brick, resulting in a village center whose architecture is substantially unified. [Encyclopedia of Chicago: Libertyville, IL, chicagohistory.org.] In 1997 the National Trust for Historic Preservation gave Libertyville a Great American Main Street Award, called the downtown. They said this is "a place with its own sense of self, where people still stroll the streets on a Saturday night, and where the tailor, the hometown bakery, and the vacuum cleaner repair shop are shoulder to shoulder with gourmet coffee vendors and a microbrewery." Now it is best known for its 70 restaurants and bars.

We will initially gather at 9:00 am in Cook Park, located at the foot of a prominent local landmark historical residence. There is plenty of street parking, and there are two parking structures within a block; all parking is free.

### LCAL AT THE JUNE 3 DANDELION WINE FINE ARTS FESTIVAL

The Lake County Art League has long showed work at the Dandelion Wine Fine Arts Festival in Waukegan's Bowen Park at the Jack Benny Center, which this year will be June 3. That may be almost 3 months away, but fees for LCAL members will be discounted \$10 if you submit your application in March. Get an application form from the Corresponding Secretary and submit it directly to the Waukegan Park District. The festival will occur during the CLC student show inside the Jack Benny Center, an event hosted by the art league. That show will run from May 16 to June 18.

### SKETCHES ARTICLES OR GRAPHICS NEEDED

We often have space for a small member's article or graphic. These give a personal touch that boosts us all and helps *Sketches* more correctly reflect the character of the art league. It can be serious or whimsical, prose or poetry, artful or an offhand doodle. Mostly it needs to be genuine and personal.

### A BEQUEST TO LCAL NEEDS AN EIN

A member who wished to leave a bequest to the art league recently said that an attorney writing the will needed LCAL's Employer Identification Number (EIN). This is also known as a Federal Tax Identification Number, and is used by the IRS to identify a business entity. The art league had to have an EIN to become a 501(c)(3) nonprofit organization. Our Treasurer provided the LCAL EIN: **90-0135168**.
