REGULAR MEETING

JANUARY 6, 2015

1. Meeting called to order by Chairman Robert Long with the following members present: Dwight Gordon, Willie Frank Thompson, Gerald Blocker and Clifton DeLoach.
2. Meeting led in prayer by Willie Frank Thompson.
3. Mr. Robert Long stated I am stepping down as Chairman.

8. Motion made by Mr. Blocker, seconded by Mr. DeLoach and carried to re-appoint Florence Baggs to the Long County Board of Health for a six year term, starting January 1, 2015. Mr. Thompson abstained from voting. Mr. Long voted yea and Mr. Gordon voted yea.
9. Motion made by Mr. Thompson, seconded by Mr. DeLoach and carried to sell the Dodge Ambulance and let the Fire Department receive the proceeds. Mr. Long voted yea, Mr. Blocker voted yea and Mr. Gordon voted yea.
