The Department of Kansas Conference is now history. A good time was had by all attending. Now is the time to renew all non-Life members. Membership Process: New members: Members who join between August 31 and the last day of February pay \$25.00 and expiration date will be August 31 (of the following year) Members who join between March 1—August 30 pay \$15.00 and expiration date will be August 31 (of the following year) Reinstatement: Members with a reinstatement date of August 31—End of February pay \$20.00 and the new expiration date will be August 31 of the following year. Members with a reinstatement date of March 1—August 30 Pay \$10.00 and the new expiration date will be August 31 of the following year. Then each member will owe \$20.00 each year following August 31.

NOW THAT THIS IS CLEAR AS MUD all non-Life members now is the time to renew your memberships with your detachment. The 06-30-2018 National Roster, Department of Kansas listed 58 members due for renewal. Paymasters, as of July 1 Transmittal numbers start at 001. Example 0682-19-001-01.

Detachments should have received their LIFE MEMBERSHIP AUDIT. Commandant and Paymaster must sign and date and return to Department Paymaster.

In May Detachment #1025's new officers were elected and sworn in to office. After the ceremonies, we held a dinner for all league members and their families.


