

This Parent Permission and Release form is reviewed and accepted by MLFA 2022 player's parent/guardian by submitting a registration form.

COVID-19: I understand the hazards of the novel coronavirus (“*COVID-19*”) and am aware that the Centers for Disease Control and Prevention (the “*CDC*”) has issued guidelines regarding COVID-19. I acknowledge that the circumstances regarding COVID-19 are changing from day to day. Accordingly, I further acknowledge that the CDC guidelines may be regularly modified and updated and I accept full responsibility for familiarizing myself with the most recent updates to the CDC guidelines relating to COVID-19. Notwithstanding the potential acknowledged risks associated with COVID-19, I hereby voluntarily choose to permit my child to participate in youth full-contact tackle football, including practices, scrimmages and games (“*Youth Football*”), through the Mt. Lebanon Football Association (the “*MLFA*”). ***I acknowledge and fully assume the risk of illness or death related to COVID-19 arising from my child's participation in Youth Football and hereby forever RELEASE, WAIVE, DISCHARGE, AND COVENANT NOT TO SUE, on my behalf and any minor children for whom I have the capacity to contract, the MLFA, their officers, directors, agents, employees, volunteers, the South Hills Youth Football league (under which the MLFA participates) and their officers, directors, agents, employees, volunteers and assigns from any and all liability related to and/or arising from COVID-19 which may occur as a result of my participation/attendance in Youth Football.***

In consideration of the acceptance of this application for my child in the Mt. Lebanon Football Association (“*MLFA*”) and for my child to be fully permitted to engage in the activities of the MLFA, I, for myself and my child, hereby agree to discharge, release, absolve, indemnify and hold harmless the MLFA, its officers, directors, members, coaches, referees, sponsors and any other person authorized by the MLFA to act in conjunction with the program, for any and all damages arising out of any and all injuries to my child. I also agree to assume all risks and hazards through my child's participation in any and all practices, scrimmages, clinics or games including those risks involving traveling to and from such activities. Should my child become injured or ill and no parent/guardian is present, I hereby grant permission for the MLFA officers, coaches, or any other person authorized by the MLFA, to obtain medical care for my child. If only one parent is signing this form, I certify that I am authorized to sign this release.
