LESLIE TILLMAN, CITY TREASURER TO GIVE FINANCIAL UPDATE.

Tillman reported city is in good shape. Revenues versus expenditures are at same place as last year. Building permits and court revenues are up. Will probably need an end of year adjustment to account for the wrecked car replacement. Sewer employee budget is a little high but sewer revenue is up. Overall city is looking very good.

Short questioned if Tillman could do a compliance audit. Tillman stated compliance is not what she does as City Treasurer.

Mayor asked Short if he thought any malfeasants were being done by city employees or the Mayor. Short stated no; not at all. Short stated he had been reading other cities audit reports from Secretary of States website and thought it might be good idea to have city do a compliance audit. Miller stated he understood where Short was coming from, but didn't think it was necessary for Fair Grove. City has excellent employees and it would cost the city thousands of dollars. Other board members agreed with Miller. Short wants to bring issue back up at budget time.

Greene County/Jornagan is gearing up for overlay project on RockRidge St. and checking to see if Senior Citizen building will be ready to asphalt parking lot.

POLICE DEPARTMENT-Sgt. Way reporting Officer Illig is back from maternity leave. Reserve Officer Proctor has retired and will no longer work as a Reserve Officer. Hired Officer Mullins as a new Reserve Officer; he comes from Seymour Police Department. Question if Police can hire the nephew of EMD Greg Porter as a Reserve Officer. Clerk will call MIRMA for HR advice. Clerk to also ask MIRMA about "Play Streets". Board wants Chief to also look at Kellen Street for speed limit signs. Sgt. Way reported he had received donations from the three banks totaling \$600 for the

Community Resource Officer program. He is using for Education Initiative project. Teaching Forensic Investigative Biology at the high school. It has been very well received. Family Pharmacy is donating some lifesaving equipment.

CITY CLERK- Clerk went over General Code option for all city documents; cloud based which is cheaper than what city is using now. Will move forward with getting more information. MIRMA evaluation of city was done in January. Score received was 93% which will give city a credit on insurance premium.

COMMITTEE REPORTS-Short Public Works-Six places seen with water on street; culverts need to be cleaned.

Counterman questioned if RV trailers are allowed in Mobile Home Park? Ault-Goodbye to everyone. It has been amazing to serve with this Board. Board gave their appreciations for her service. Ault is continuing on Planning and Zoning. Miller also thanked the Police Department for the work they are doing.
