Old Business:

1) Marysville Township Board met with Brent Larson of Hakanson Anderson and is developing road standards for Marysville Township and should have them complete 1st quarter 2021.

New Business:

1) Scott Dahlke on behalf of Brad Paumen and Brian Matzke was present to discuss 346 Co Rd 12 S off Mink Lake. Brad has a petition to rezone the north 4 acres from A/R & S-2 to R-2 & rezone 4.46 acres from A/R & S-2 to S-2 to allow the expanding of existing 1.41 acre lot owned by Matzke, and the balance of the South 17.3 acres will remain A/R. And request a CUP for a 3-lot un-platted subdivision (one lot is Matzke's current house).

After discussions, the Town Board is under the impression this land is still in Agriculture. A motion to deny the request was made by Joe Hickman, 2nd by Jane Hurley as it does not fit current comprehension plan and carried 2-0. The applicant is on the November 12th Wright County Planning and Zoning Meeting.

4) A motion to accept the Marysville Township Sign Maintenance Certification was made by Jane Hurley, 2nd by Joe Hickmann and carried 2-0.

6) A motion to leave the December Meeting on December 28th, 2020 was made by Jane Hurley, 2nd by Joe Hickman and carried 2-0.
