CORRESPONDENCE FROM THE FISCAL OFFICER:

FIRE DEPARTMENT:

Fire Chief Golden reported that Hocking Township had 264 runs to date. Monthly runs so far have been 3 fire and 25 EMS. There were a total of 14 mutual aids provided to Amanda, Lancaster, and Berne Townships. County Fire Association Meeting will be held at our department this year. We will be utilizing the administration building for seating. The department is hosting a free EMS class provided by MedFlight and is open to all county fire departments.

OLD BUSINESS

1. The new ODOT signs are on schedule.
2. The property of Jon and Cathy Born is being worked on with Fairfield County Soil and Water.
3. Trustees are obtaining scrap prices for the old EMS unit.
4. A list of road issues was given to the maintenance staff that were found from the Trustees meeting. They will be working on those issues.

NEW BUSINESS:


1. Need to bid for winter salt contract. Trustee Claypool motioned to use the DAS contract for our salt needs. Trustee Ellinger seconded the motion. Roll call vote Ellinger – Yes, Claypool – Yes Motion approved.
2. Trustee Ellinger motioned to use Bigham's submitted quote to extend the road ditch culvert on Hopewell Church Road to stop erosion toward the road in the amount of \$1,296.40. Trustee Claypool seconded the motion. Roll call vote Ellinger – Yes, Claypool – Yes Motion approved.

Trustee Ellinger moved to pay the warrants for the month seconded by Trustee Claypool. Roll call vote Ellinger – Yes, Claypool – Yes Motion approved.


There being no further business to discuss Trustee Wolfe motioned to adjourn and Trustee Claypool seconded the motion.




