**Bottled ice water supplies will be limited**

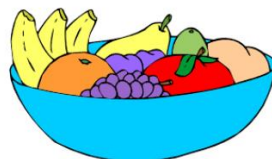

## DIRECTIONS

### Island Grove Park – 11<sup>th</sup> Ave N & D St

Use 11<sup>th</sup> Ave (NO access via 14th Ave)

**From the North** - From Hwy 85 take the 11th Ave exit. Proceed South to park entrance.

**From the South** – From Hwy 85 take the 5<sup>th</sup> St exit and go West to 11<sup>th</sup> Ave. Proceed North on 11<sup>th</sup> Ave to park entrance.

**From the East or West** – From Hwy 34 Business Route take 11<sup>th</sup> Ave North to park entrance.

**From I-25 North or South** – Take Hwy 34 East to Business Hwy 34 exit. Continue East to 11<sup>th</sup> Ave. Proceed North on 11<sup>th</sup> Ave to park entrance.
