PRE-BUDGET MEETING OCTOBER 18, 2021

CALL TO ORDER: The special meeting of the Town of Eaton was called to order by Chairman Rick Christel at 6:00 p.m., Monday, October 18, 2021 at the Eaton Town Hall. The Pledge Allegiance to the flag was recited by all.

MEETING NOTICES: Meeting notices were posted at the Eaton Town Hall, and the Town Website

ROLL CALL: Rick Christel, Chairman; Adam Schetter, Supervisor, Lewy Schema, Supervisor, Paulette Vogt, Clerk, Pam Schneider, Treasurer, and Craig Zipperer, Road Superintendent were in attendance.

AGENDA: The agenda had been emailed previously. Supervisor Schema made a motion to accept the agenda, and Supervisor Schetter 2nd the same, motion carried.

The 2022 budget was then worked on. After some discussion, it was decided to give Road Superintendent an increase of wage by \$1.00 per hour starting January 1, 2022. A motion was made by Chairman Rick Christel and 2nd by Supervisor Schema that the vacation days for 2022 would be 12 days with no sick days. The wage for Road Superintendent Zipperer would be \$28.00 per hour. Motion carried. A new contract will be re-written.

Chairman Christel made a motion to allow the clerk to adjust the 2022 budget figures. Supervisor Schetter 2nd said motion. Motion carried.

A motion was made by Chairman Rick Christel that the regular monthly November board meeting will be held on November 8, 2021 at 6:30 p.m. The Public Budget Hearing will follow at 7:30 p.m. on this same date. Supervisor Schema 2nd the motion. Motion carried.

November 9, 2021 at 8:00 p.m. will be the meeting of the St Nazianz Fire Department. The Town of Eaton Board will attend this meeting.

A motion to adopt resolution 1-2021 approving the use of carry-over tax levy capacity for the 2021 tax levy funding the 2022 town operating budget was made by Chairman Christel as well as a motion to adopt the 2-2021 Resolution of Town Board Proposing to Exceed Levy Limit Via Special Town Elector Meeting. Supervisor Schema 2nd the motions. A vote was taken: Chairman Christel – yes, Supervisor Schetter – yes, and Supervisor Schema – yes. Motions carried.

Supervisor Schema made a motion to adjourn the meeting. Supervisor Schetter 2nd the same. Motion carried.

Meeting adjourned at 8:05 p.m.
