Fees: Pre-Entry Fees are \$20 for each titling class; \$15 for Introduction to Quarry. Day of entries are \$25 for each titling class and \$20 for IQ. EE entry fees are \$35 pre-entry and \$40 day of entry. Please make checks payable to "CATC". **All funds submitted must be in US currency.**

RETURNED CHECKS do not constitute a valid entry fee. A charge of no less than \$25.00 will be made for each returned check.
