Happy Feet Equals Learning Feet

After a successful year of volunteer support, community contributions, and positive publicity, the Happy Feet Equals Learning Feet project is announcing its fundraising effort for this year's campaign. Once again we will partner with Shoe Carnival to put smiles on the faces and quality athletic shoes on the feet of hundreds of Union County students.

Eligible children will be identified with the help of the Family Resource/Youth Service Center directors at each school. Each September, the selected students will be fitted by Shoe Carnival employees and trained local volunteers to ensure that each child receives shoes that have been properly sized. Next, each child will choose a pair of shoes from a predetermined selection based on the individual's age. Soon after, Shoe Carnival will place the order and the shoes will be delivered to the children at their respective schools in October after Fall Break. In addition, the Happy Feet Equals Learning Feet program will provide shoes on a case-by-case basis as emergencies arise throughout the year and for special events such as graduation.

How can you help with this community action program? Since the cost of one pair of shoes is approximately \$30.00, you could make a personal donation, or if you are truly inspired by this project, you could organize a book club, youth group, card club, Bible study class, or fellow employees to sponsor shoes. Even better, you could approach the management at your place of employment to participate as a corporate donor in this worthy endeavor.
