A \$120 application fee must accompany the application, payable to Leisure Time RV Park. It must be received by January 31st to reserve the space assigned to you the previous year. Please be aware, this is a non-refundable application fee. Please attach your check to the application and return immediately. Your space will be available to others if the payment has not been received by January 31st. One space allowed per Association Member. If you did not use your space last year you will not be given the same space number this year.

On February 10th remaining spaces will become available. They will be filled in the order the applications were received. If there are no remaining spaces available, your name will be placed on a waiting list and your check will be returned. You will be contacted if a space becomes available and your name is the next on the waiting list. Additional forms are available on our Web Page.

You will receive a confirmation letter with your assigned space by April 1st. All remaining spaces, if any, will be available throughout the year, but the Application Fee will remain the \$120 regardless of the months remaining in the year.
