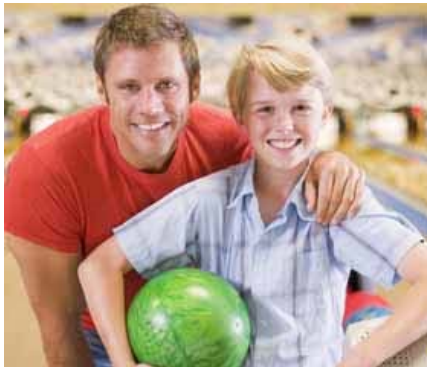

Midwest USA Adult-Junior Doubles Championships Rules

Schedule: This is an Adult-Junior scratch doubles bowling tournament. It is operated by Midwest USA Scholarship Tournaments, LLC. Greg Coullles, Director. Tournament date: Saturday, April 3, 2021. Location: Beaver-Vu Bowl 1238 N. Fairfield Rd., Beavercreek, OH 45432. daytonbowling.com.

Doors open at 9:45 AM. Warm-ups at 10:50 AM. Tournament play begins about 11:00 AM Eastern time, subject to on-site adjustments. A team will consist of one adult bowler and one youth bowler. There are two divisions: a division for an adult bowler teamed with a youth bowler age 15-20 and a separate division for an adult bowler teamed with a youth bowler age 14 and under. The youth bowler's age on August 1, 2020 will be the determiner of division enrollment. **NOTE: This is an "age-based" tournament, not a USBC membership-based tournament.** A bowler age 20 and under (as defined) may participate as the youth bowler in this tournament even if that bowler has a USBC adult membership. Bowlers registered as a youth bowler may only earn scholarship (not cash) awards regardless of age. The adult bowler must be age 21 & older as of 8.1.20. The gender of either the adult or the youth bowler is NOT a consideration. A male may bowl with a male or female, or vice versa. **Maximum allowed teams: TBA based on State of Ohio facility capacity requirements in effect in April, 2021. If not stipulated by the State: 120 max. teams.**

Format: Qualifying Round: Each team will bowl a Qualifying Round of four (4) games of regular tenpin bowling. 24 teams in the 15 & older division and 12 teams in the 14 & under division, based on total team Qualifying Round scores, will advance to the Championship Round (subject to change on-site based on number of divisional entries). Ties for the final advancing Qualifying Round teams will be broken by the high single game score rolled by a team.

Championship Round: The scores from the Qualifying Round will be dropped. All Championship Round games will be Baker games in which the youth bowler will bowl the even-numbered frames and the adult bowler the odd-numbered frames. Each team will bowl two (2) "Baker" games with each game bowled entirely on 1 lane, switching lanes on the same pair after each game. The field will be cut after each 2 Baker game set based on the team's 2-game Baker total. There will be four (4), 2-game Baker sets in the 15 & older division and three (3), 2-game Baker sets in the 14 & under division. The number of teams that will advance after each Baker game set will be posted in the tournament office. **Championship Round Placement:** In both divisions, higher placement in the final tournament standings will be based on the scores rolled in final two (2) game Baker set in which a team participated. **Ties:** all ties for any advancement will be broken by a 9th/10th frame roll-off in which the adult bowler will bowl the 9th frame and the youth bowler the 10th frame.

Lane Pattern/Surface: The lane pattern will be posted at tournament check-in. Beaver-Vu Bowl has Brunswick Pro-Lane synthetic lanes & textured synthetic approach surface.

Cost: The pre-paid (*received before 5:00 PM, Friday, 4.2.21*) entry fee is \$90.00 per team. Breakdown: lineage, publicity, staffing, awards: \$55.00. SMART Scholarships for youth bowlers: \$35.00. Total pre-paid entry fee: \$90.00. **The Midwest USA Scholarship Tournaments will add \$15.00 per youth bowler to the total scholarships awarded!** Note: entries received after 5:00 PM, Friday, April 2, 2021 will be charged an additional \$10.00 late processing fee. The closing date for entries is Saturday, April 3, 2021. **Only paid entries will be accepted.** Walk-ins will be accepted subject to lane availability. **Phone calls & E-mails asking to reserve an unpaid spot with the intention to participate will not be honored.**

General Rules: Abuse of equipment, foul or disruptive language, gestures, and/or unprofessional behavior by bowlers or spectators are cause for the non-refundable dismissal from participation or attendance at this tournament. All bowling equipment must meet USBC specifications. **The use of powder or any foreign substance (including rosin & Easy Slide) on shoes, the approach, or on the facility floor or carpet is not permitted. USBC regulations regarding altering a ball surface will be enforced.** Only participating bowlers and officials are permitted in the bowling area. The Tournament Manager has the right to refuse any entry. The bowler, by voluntary participation in the event, acquiesces to the final authority of the Tournament Manager to make necessary on-site changes and to interpret and enforce all rules, regulations, and procedures. Any unforeseen or not described situation(s) will be regulated by USBC rules with interpretative judgment guided by the best interest of youth bowling and this event.

Awards: The youth bowler on no fewer than one of six teams (1:6) in each division will be awarded a SMART scholarship. In addition, the top 4-game series rolled during the Qualifying Round by a boy and a girl in each age division will receive a \$50 SMART scholarship (4 awards x \$50 = \$200 total). Optional high game scholarship jackpots will be available for youth bowlers. Optional adult brackets and/or high game jackpots will be separately available. 100% of all collected scholarship funds & awards for youth bowlers will be awarded and sent to the SMART Program for management and dispersal (Acct. #8871). SAFETY POLICIES REGARDING COVID-19 for the 2020-2021 tournament season.

To Athletes, Parents, & Spectators:

updated: 1.27.21

The covid-19 crisis has affecting everyone and everything in our lives. Ohio bowling centers are now open and we are obligated to conduct bowling tournaments under the safety policies mandated by both the State of Ohio and the individual bowling center.

As we have seen, the mandated safety policies are subject to change at any time at the will of the State of Ohio. The policies may vary from center to center depending on location and size. To conduct a tournament, we must follow the safety policies in effect on the date of the tournament at that center. Compliance is required.

Each bowling center can determine its own covid-19 safety policies in its requirement to comply with State of Ohio mandates. It is the obligation of each bowling center, as a condition to be open for business to dictate to a tournament, among other things, their policy regarding:

1. The number of lanes to be used and left unused (if any).
2. The maximum numbers of bowlers allowed on each used lane.
3. The maximum number of spectators allowed in the facility.
4. Conditions for admission into the center (i.e.: mandatory no-touch temperature readings, face masks, hand sanitization, social distancing, open facility doors, lane movement, use of center equipment, more, etc.).

The primary way we communicate with our bowlers is via e-mail. Every tournament entry form requires that bowlers or a parent list their e-mail so that if there are changes in any aspect of the tournament you will be informed. **This means that you should check your e-mail daily for any updates.** This is easy to do on your computer, tablet, or smart phone. It is not possible to telephone or U.S. Mail every bowler regarding tournament changes. ***If we e-mail an update (or if your e-mail was incorrectly shown on the entry form) and you miss it, we cannot be responsible on the day of the tournament or at the point of admission.***

It is the best interest of everyone that we remain safe and have fun at bowling tournaments. The State of Ohio and bowling center safety policies are design to offer the safest venue possible and allow everyone to get back to normalcy. Please comply with the safety policies in effect at a bowling tournament and use simple common sense in your conduct with others. How long the covid-19 public safety policies will be in effect and how they might evolve over time is anyone's guess. Please do not hesitate to call or-email me if you have any questions.
